Respectfully;

1. That the petitioner is voter of constituency No.PP 167 Village Niaz Baig and the same was part of PP-167 Lahore XXIV. As per notification No. F8 (8)/2018-Elc-R dated 5<sup>th</sup> Mach 2018, mentioning the Charge 55 and circle No.4 & 6 of charge No.1 Lahore Tehsil in preliminary report of the list of constituencies of Provincial Assembly.
2. That the petitioner is aggrieved by the new delimitation and seeks proposed delimitation in PP-167 of Lahore District under following amongst the other:-

1. That the new delimitation as published in preliminary report and preliminary list is against the provisions of section 20 of Election Act, 2017 read with rule 10 and 12 of the Election Rules 2017.
2. That the Election Commission wrongly divided the area of village Niaz Baig Thokar in two different PPs i.e. 167 and 168 unlawfully.
3. That the village Niaz Baig is one unit/entity since pre-partition and now that has been divided into two parts ignoring the homogeneity sectors and the ties of the masses.


