- 1. That I am resident of above said address and voter member of the village Bama Bala. I am enrolled through vote No157, block code 193070906 in this constituency.
- 2. That election commission of Pakistan published preliminary proposal of the proposed constituencies on March 05, 2018.

4. That the basic principle for proposal of the delimitation of constituencies section 10, sub section 05 is as under :-

"as per as possible the limitation of the constituencies of an assembly start from north end of the district, or, as a case maybe, the agency and then proceed clockwise in zigzag manner keeping in view the population among the constituencies of the assembly shall remain as close as maybe practicable to the quota"

Provided that the quota under this sub rule shall be determined by dividing total population of the District or the agency with the number of seats allocation that district or agency.

5. That according to section 20 principles of delimitation sub section 1 is as under:-

"All constituencies for general seats shall, as far as practicable, be delimited having regard to the distribution of population in geographically compact areas, physical features, existing boundaries of administrative units, facilities of communication and public convenience and other cognate factors to ensure homogeneity in the creation of constituencies."

- 6. That the total population of District Okara is 3,039,139 and the constituency for provincial assembly of district Okara are eight in number and population of each constituency should be 3,79,892 which can be increased up to ten percent in accordance with law.
- 7. That in the north of District Okara, the boundary of District Okara is divided by the river ravi and along the river Ravi following QH,s of District Okara are as under:-

Except the Chuchak QH rest of all the three QHs falls in Tehsil Okara.

- 8. That convener of the delimitation committee has considered chuchak QH of tehsil Renala Khurd north end of the District so PP183 Okara-I is taken as a first constituency of District Okara having the population of the constituency 3,74,528 which consist of chuchak QH, Renala-1, Renala Muncipal Committee and Renala-II along with following PCs of Satghara QH.
 - 1. PC 12/1R
 - 2. PC 15/1R
 - 3. PC 17/1R
 - 4. PC 31/2R and Satghara.

It's brought in knowledge of the honorable authority that no PC of 31/2R exist in Satghara QH while the correct No of the PC is 32/2R which no way joins in any of the above said PCS rather it is overlapping the aforesaid PCs while map issued by Election Commission of Pakistan for the constituency PP183 Okara-I, 25/2R PC having population 15,236 has been shown within the limits of PP183 Okara-I

- 9. That the population of Tehsil Renala Khurd chuchak QH is 1, 18,317, Renala-1 population is 82816, Renala Municipal Committee population is 54097, Renala-II population is 71029, becomes 326259.according to the law while traveling zigzag towards the north kohla QH of Tehsil Okara comes in the way. Renala-II QH has been wrongly added in the above constituency and including the kohla QH having population 72,709 after excluding the PCs, Bakhshu,kako and jandraka having population 30016 meets the basic requirement for the constituency.
- 10. That in PP183 Okara-I proposed constituency published on March, 05, 2018 is against the basic law and election Act 2017 specified in section 10, subsection (05) and section 20,



11. That due to the above said gross violation of the election Act 2017 present objection is being filed for the proper and correct limitation of the constituency.

IN LIGHT of the above said submission, it is respectfully prayed that the Objection petition for PP183 Okara-I be accepted and population of constituency PP183 Okara-I be amended as proposed in this objection petition.
