OBJECTION PETITION AGAINST THE PROPOSAL
PREPARED BY CONVENER DELIMITATION
COMMITTEE FOR CONSTITUENCY NO PP 183 OKARA-I

Respectfully Sheweth,

1. That I am resident of above said address and voter member of the Municipal Committee Renala Khurd. I am enrolled ~~in constituency No. 185~~, Block Code 195130407 in this constituency.
2. That election commission of Pakistan published preliminary proposal of the proposed constituencies on March 05, 2018.

4. That the basic principle for proposal of the delimitation of constituencies section 10, sub section 05 is as under :-

“as per as possible the limitation of the constituencies of an assembly start from north end of the district, or, as a case maybe, the agency and then proceed clockwise in zigzag manner keeping in view the population among the constituencies of the assembly shall remain as close as maybe practicable to the quota”

Provided that the quota under this sub rule shall be determined by dividing total population of the District or the agency with the number of seats allocation that district or agency.

5. That according to section 20 principles of delimitation sub section 1 is as under:-

“All constituencies for general seats shall, as far as practicable, be delimited having regard to the distribution of population in geographically compact areas, physical features, existing boundaries of administrative units, facilities of communication and public convenience and other cognate factors to ensure homogeneity in the creation of constituencies.”

6. That the total population of District Okara is 3,039,139 and the constituency for provincial assembly of district Okara are eight in number and population of each constituency should be 3,79,892 which can be increased up to ten percent in accordance with law.

7. That in the north of District Okara, the boundary of District Okara is divided by the river ravi and along the river Ravi following QH,s of District Okara are as under:-

Except the Chuchak QH rest of all the three QHs falls in Tehsil Okara.

8. That convener of the delimitation committee has considered chuchak QH of tehsil Renala Khurd north end of the District so PP183 Okara-I is taken as a first constituency of District Okara.
9. That the total population of Tehsil Renala Khurd is 4,58,572 while the population of chuchak QH is 1,18,317 and adjoining QH Akhtarabad's population is 1,32,268 and population of Renala Khurd I QH is 82,861 and the population of Renala municipal committee is 53,997 so that total population of Chuchak QH, Akhtarabad QH, Renala I and Renala Municipal committee is 3,87,443 which is the basic population of the constituency so the PP183 Okara I is according to the law of limitation of Election Act 2017.
10. That in PP183 Okara-I proposed constituency published on March, 05, 2018 is against the basic law and election Act 2017 specified in section 10, subsection (05) and section 20, subsection (1).
11. That in the proposed PP183 Okara-I in which PCs of Satghara QH of Okara tehsil namely chak No 12/1R, 15/1R, 17/1R, 31/2R and satghara are wrongly included and same way Renala-II QH has also wrongly included in PP 183 Okara-I which is against the basic law of limitation of the constituency. So, the above said petition is being filed for the correction of PP183 Okara-I according to basic rules of limitation of constituency for the provincial assembly laid down in the election Act 2017 for the purpose of limitation of the constituency.

12. That the excessive population of tehsil renala khurd-II is 71,029 be added in PP185 Okara-III excluding the Akhtarabad QH while traveling clockwise towards south.

IN LIGHT of the above said submission, it is respectfully prayed that the Objection petition for PP183 Okara-I be accepted and population of constituency PP183 Okara-I be amended as proposed in para No 8 of this objection petition.
