

OBJECTION PETITION AGAINST THE PRELIMINARY DRAFT PROPOSALS OF THE DELIMITAION COMMITTEE IN RESPECT OF THE DELIMITAION OF TERRITORIAL CONSTITUENCIES OF THE DISTRICT SAHIWAL WITH REGARD TO PUNJAB PROVINCIAL ASSEMBLY SEATS.

RESPECTFULLY SHEWETH:-

The petitioner submits as following as:

- 1. That the petitioner is resident of chak no.59/GD Teh. & Distr. Sahiwal and also voter in constituency of PP-199 Sahiwal-IV District Sahiwal according to preliminary delimitation territorial constituencies.
- 2. That vide Notification No.8(3)/2018-Elec-I preliminary report and list of constituencies in respect of national and the Provincial Assemblies has been published by The Election Commission of Pakistan on the 5th march,2018. The population of the Province Punjab was divided by the total number of general seats allocated to the Punjab Assembly for obtaining quota per seat,

The share of District Sahiwal was determined by dividing the population of District Sahiwal with quota per seat of Punjab Assembly,

 That the petitioner seeks alterations, amendments and modification in the preliminary proposals of delimitation of territorial constituencies of District Sahiwal in respect of Punjab Assembly seats on following amongst others,

OBJECTIONS

- a. That delimitation in constituency of PP-198 Sahiwal-III and PP-199 Sahiwal-IV has not been done in a clockwise fashion starting from the north which is clearly violation of The Election Rules 2017 and exercise was not carried out meticulously.
- b. That while splitting/adding the Population(46689) of Patwar circles


into Quota PP-199 Sahiwal-IV, The Delimitation Committee has not followed the princilpes of delimitation as laid down in section 20 of The Election Act 2017.

- c. That The Delimitation Committee has added the above given patwar circles into PP-199 Sahiwal-IV without adopting procedure given in The Election Act 2017 and has totally ignored the guidelines provided by the Commission.
- d. That according to existing boundries of administrative units, facilities of communication and public convenience insertion of above given Patwar Circles into territory of PP-199 Sahiwal-IV is not proper and is against the interests of 46689 peoples.
- e. That Geographically it is better to add above said Patwar Circles into PP-198 Sahiwal-III.
- f. That according to preliminary proposals delimitation PP-198 Sahiwal-III covers surroundings area of the City Sahiwal but above given patwar circles has not been added into the constituency of PP-198 Sahiwal-III although these patwar circles are also surrounding area of the city sahiwal and located north side of the constituency, this basic fact is also ignored by The Delimitation Committee.

It is ,therefore, respectfully prayed that the objection petition of the petitioner be accepted and preliminary proposals of delimitation of territorial consequences of District Sahiwal in respect Punjab Assembly seats be altered, amended and modified and Patwar Circles (87/6-R), (88/6-R), (59/GD), (56/GD), (60-61/GD) be departed from PP-199 Sahiwal-IV and be added in PP-198 Sahiwal-III. Similarly Patwar Circles (130/9-L), (124/9-L), (127/9-L), (105/9-L), (129/9-L) be departed from PP-198 Sahiwal-III and be added in PP-199 Sahiwal IV.

Any other relief which this Hon'ble Commission may deems fit and proper under the circumstances may also be awarded.
