REPRESENTATION under Rule 12 of the Election Rules 2017 read with CHAPTER III of the Election Act 2017 and all other enabling provisions of law in respect of delimitation of Provincial Assembly Constituencies in District Sahiwal.

## Respected Sir,

- 1. The instant Representation is being filed by Malik Imran Tariq Dhaku (hereinafter referred to as the "Petitioner"), holder of NIC # 36502-1177524-1 and registered voter member of Chak NO 112/9-L Patwar Circle (PC), Block Code 208081504 Serial No. 312 which falls under Provincial Assembly Constituency, PP-198 Sahiwal-III (previously PP-222 Sahiwal-III) as per the Preliminary Delimitation Report 2018 published by the Election Commission of Pakistan.
- 2. Through this Representation, the Petitioner seeks to challenge the Preliminary Proposal published by the Election Commission of Pakistan pertaining to the delimitation of Provincial Assembly Constituencies of District Sahiwal. The map of district Sahiwal provided by the Provincial Election Commission as per the Preliminary Delimitation Report 2018 is attached as **Annexure-A**.
- <sup>3</sup>3. In the Preliminary Proposal, Sahiwal District has been divided into

- 4. It is pertinent to mention here that the welfare of the local populace is of paramount importance to the Petitioner who belonging from a political background is well appraised of the current dynamics in the area.
- 5. That the relevant Delimitation Committee failed to adhere to the mandatory principles and procedures in letter and spirit. The Preliminary Proposal is in sheer violation of the Statutory Principles of Delimitation as enshrined in Chapter III of the Election Act 2017, Section 9 of the Delimitation of Constituencies Act, 1974, thus it is necessary to make an amendment/alteration. No heed has been paid by the Delimitation Committee to the principles of compactness, contiguity and public convenience etc.
- 6. The Petitioner proposes that the following changes be made:
  - I. **PP-196 Sahiwal-I:** The Petitioner proposes the exclusion of the following PCs falling under Yousaf Wala QH from PP-196 and their addition to PP-198:



## GROUNDS



- B. There is no direct communication link from PP-198 to Chak NO. 78/5-R PC and Chak No. 81/5-R PC. Since they are cut off from PP-198 by the National Highway and the bridgeless Lower Bari Doab. The only possibility to approach them is by travelling firstly through PP-197 and PP-199 and then to the aforementioned PCs. Is such it is desirable that these PCs be added to PP-199 with which they are contiguous and easily approachable for the sake of compactness and public convenience.
- C. There is no population/typographical link of PCs Chak NO 90/9-L and 94/9-L with PP-198 Sahiwal-III and they are physically more aligned, homogeneous and directly linked with PP-196. To access the aforementioned it is imperative to travel firstly into PP-197 and then to approach PC Chak NO 94/9-L especially Chak Nos 086/9-L and 089/9-L, Sahiwal Bunga Hayat Road has to be taken. Since majority part of Sahiwal Bunga Hayat Road falls under PP-196, it is advisable to add Chak NO 94/9-L PC in the same due to physical proximity and ease of communication. PCs Chak NO 90/9-L and 94/9-L are just random pockets difficult to access when kept inside PP-198. But they are naturally aligned to PP-196. Sahiwal Bunga Hayat Road which is a part of PP-196 is the best and easy approach for villages falling in the aforementioned PC.
- D. Due to their physical proximity to Sahiwal Pakpattan Road which falls mainly under PP-198, the following PCs merit exclusion from PP-196 and addition to PP-198:

Accessing these PCs from PP-198 is easier and convenient.

E. Due to their physical proximity to the Sahiwal-Arifwala-Bahawalnagar Road which falls under PP-198, the following PCs merit exclusion from PP-199 and addition to PP-198:

- This amendment shall be in the interest of public convenience and communication. Additionally, these PCs do not form a geographically compact area of PP-199 and are in the shape of a pocket which is physically contiguous to PP-198.
- F. That the proposed amendments will help exclusion of random pockets and bringing the constituencies in line in a zig zag manner and in a compact area which shall be easily accessible from the respective constituencies.
- G. The Preliminary Proposal has disturbed the uniformity and compactness of the constituencies; hence it has become necessary to incorporate the amendments.

In view of the foregoing, if the Preliminary Proposal is finalised without incorporating amendments suggested by the Petitioner, the entire population of District Sahiwal will suffer irreparable loss and hardships and their miseries would increase manifold.

Hence, it is most respectfully prayed that the instant representation may kindly be accepted and the amendments suggested by the Petitioner may
