Therefore, these PCs excludes from PP-200 and include PP-199.
- (iii) The PCs 139/9L, 140/9L, 152/9L, 153/9L, and 121/9L of Naiwala QH historically, physically, and geographically have no concern with PP-199 Sahiwal-IV. Therefore, these PCs excludes from PP-199 and include PP-200
