OBJECTION PETITION AGAINST THE DELIMITATION OF CONSTITUENCY PP 202 PASSED BY THE ELECTION COMMISSION, PAKISTAN

Respectfully Sheweth:

1. That, the proposed provincial map of the ECP contravenes its own laid down principle of starting the delimitation in the north and moving clockwise in the district. A cursory look at the proposed ECP map would reveal that there is no uniformity in delimitation. This tendency augments as it enters Tehsil Chichawatni, where the fragmented and jagged PP 201 and 202 presents itself as ample proof. My attached proposed provincial map is more compact and removes this apparent aberrance.
2. That, the canal distributary 14-L supplies to 41 chakook that have shared history, culture and interests. Their livelihood depends upon the smooth supply of irrigation water. They all share one Farmer's Organization (FO) under the PIDA act to address their disputes/ maintenance. Under the proposed ECP map 9 of these Chakook have been put in PP201. I have proposed to keep all these Chakooks together in PP202.
3. That, there are 33 chakook comprising ethnically local population with shared history and culture who have historically been together before the delimitation of 2001. They again have been split, nine chakook 114/7R to 122/7R and Chak Burzi to PP201 and 23 Chakook 10,11,12,14,15,18-37 of 14L to PP 202. Thus, diluting their shared political influence. My proposal includes all 33 chakook of ethnically local population in PP202 best preserving their rights.
4. That, there are two Ghalla Mandis and two Market Committees in Tehsil Chichawatani. Under the ECP proposed map both have been put in PP201, While my proposed map provides one Ghalla Mandi and Market Committee to each of the two provincial constituencies in Tehsil Chichawatni.

- 5. That, there are five police stations in Tehsil Chichawatani. Three of these police stations are being shared between the two constituencies under the proposed ECP map. In my proposal PP 202 would comprise boundaries of two police stations in their entirety. This further demonstrates the superior compactness of my proposed map.
- 6. That, there are two sub-divisional offices of MEPCO electric supply network. Under the proposed ECP map both have been put in PP201. In my proposal one sub-divisional office would go to one provincial constituency. Thus, better preserving the rights of the constituents.
- 7. That, due to the above factors over a period of time better road connectivity has developed between the three QHs of Shahkot, Iqbal Nagar and Kassowal. Similarly, there is better connectivity between the three QHs of Okanwala, Chichawatani and MC Chichawatani. The ECP proposal transacts the naturally existing road network.
- 8. That, the population difference under the ECP proposal between the two constituencies is 32,716 while it would be reduced down to 10,836 which would be fairer and closer to the ECP declared aim.

In view of the above submissions I **propose** to swap QH Kassowal with QH Okanwala between the two PP constituencies. Moving QH Okanwala to PP201 and QH Kassowal to PP202.
