MEMORANDUM / OBJECTION PETITION AGAINST THE PRELIMINARY DELIMITATION / DRAFT OF CONSTITUENCIES NO. PP-258 TO PP-260 and PP-261 DISTRICT RAHIM YAR KHAN.

RESPECTFULLY SHEWETH,

That the petitioner is resident of R/O 34-P, Tehsil Khan Pur District Rahim Yar Khan, CNIC No. 31301-7106379-3, Cell No. 0334-814114 and is registered voter on Serial No. 294, Gharana No. 107, Census Code: 251040407 in District Rahim Yar Khan in Constituency No. PP-

261 Rahim Yar, Khan, Vote Certificate is attached here with as Annexure A.

- 1. That the Preliminary delimitation / draft published by the Election Commission of Pakistan is against the Law, Rules, Province Sections, and Guide Lines Laid Down in the Delimitation Rules and Act 2017.
- 2. That the preliminary delimitation of constituency No. PP-258, PP-260 and PP-261, District Rahim Yar Khan is against the Laws, Rules, Principles, Provision Sections, so is Liable to be rectified, modified and revised and to be formulated with in the prescribed province Section, Rules, Laws, Under the Delimitation Act and Rules, 2017.
- 3. That the formulation of all three PPs i.e 258, 260 and 261 is against to the Law, Rules, Province Sections, and Guide Lines Lad Down in the Delimitation Rules and Act 2017 because all three constituencies have been delimited and formulated from East to West which is contradictory and repugnant to the basic principles of delimitation which is from North to South and clock wise. But all the three constituencies PP-258, PP-260 and PP-261 have been formulated while keeping all the Laws, Rules, Principles, Provision Sections, which is labile to be rectified, modified and revised.
- 4. That into to sequence the formulation of PP-260 has been also violated and deviated which is against golden principles of delimitation.
- 5. That the Election Commission of Pakistan has negated violated and deviated the Rules, Principles and the three constituencies as it has not been delimited clock wise from North to South and keeping away all the Fundamental Rules Compactness of Population and arrears, existing boundris, social of communication, Public convenience and Public interest. Map of Election Commission of Pakistan is attached here with as Annexure B.

6. That the delimitation of three the constituencies is liable to be rectified, modified under the grounds.

GROUNDS

- 1. That Patwar Circle Chak No. 31-P PC Jhol and PC Sher Ghar have been included in PP-261 against the fundamental Rules, Principles, Laid Down in the delimitation Rules in Act 2017. Which is stated from East to West and its length is approximately more than 80 Km and this constituency is under the different three National Assembly Constitutions with can be perused in the preliminary map / draft.
- 2. That PCs 31-P Jhol and Sher Gharl are part and partial of PP-260 which liable to be excluded from PP-261 and to be included in PP-260 being very close nearest and adjacent to Tehsil and Head Quarter Khan Pur.
- 3. That if we travel from the one part of PP-261 we have to class at lest more than five provincial constituencies and three national constituencies so it is the violation of fundamental basic principles of delimitation.
- 4. That Population of PCs Gulan Galkala Jetha Bhutta and Amir Pur has been included in PP-260, against the Rules, Laws, Section, Provisions, Laid down in the Delimitation of Act 2017. Which liable to excluded from PP-260 and to be included in PP-258.
- 5. That PCs Dunya Pur, Izafi, Dunya Pur and Latki have been included in PP-258, District Rahim Yar Khan against the compactness of arrears existing bounders common cources of communication as well as in the

public interest which is liable to be excluded form PP-258 and to be included in PP-261.

6. That under the proposal of the petitioner all the three constituencies become comfortable and ideal in all respective Rules delimitation.

- III. That PC Duyna Pur Izafi, PC Dunya Pur and PC Lathki be excluded from PP-258 and be included PP-261 District Rahim Yar Khan.
- IV. Proposed shape of constituencies PP-258 and PP-260 and PP-261 Rahim Yar Khan.
