REPRESENTATION

UNDER SECTION 21(3) ELECTIONS ACT 2017 READ WITH RULE 12 OF
ELECTION RULES 2017 REGARDING ALTERATIONS FOR
MODIFICATIONS IN THE PRELIMINARY LIST OF CONSTITUENCY
PP-265, PP-266 & PP-267 OF RAHIM YAR KHAN DISTRICT

Respectfully Sheweth,

1. That the petitioner is a registered voter and Chairman of Union Council # 173/P and Member District Council Rahim Yar Khan. As per notification No. F8(3) /2018-Elc-I dated 5th March 2018, the whole constituency has been changed without any identical logic and evenly not justified in preliminary report of the list of constituencies of Provincial and National Assembly, published by the Election Commission of Pakistan.
2. That the undersigned is aggrieved by the new delimitation and seeks proposed delimitation in PP-265, PP-266 & PP-267 without bringing major changes in the constituencies of Rahim Yar Khan District inter-alia on the following amongst other:-

Grounds:

- a) The population of the Constituency of PP-266 is not appropriately divided because it is overlapping to PP-265 which is not geographically and physically intact with each other.
- b) The Qanogo Halqa Machka is wrongly attached with the PP-266, which should be the part of PP-265. Resultantly it will become the natural boundary and all the area falling in PP-266 will remain geographically intact and there would be no overlapping of the one constituency to another constituency.
- c) The physical feature also does not match because the communications, public convenience and homogeneity have not been kept in view. Distance from one end to the other of constituency is spread over 100-KM. Culture and living of Machka is completely different from the rest of Constituency.
- d) The PC Sanjarpur Nao may be excluded from PP-265 and may included in PP-266 whereas PC Sadiqbad I may be excluded from PP-267 and included in PP-266, obviously, these are the natural part of PP-266.
- e) Patwar Circle Qasmani of Qanogo Halqa Shahbaz Pur may be excluded from PP-266 and included in PP-265 because this PC has been un-necessary attached with PP-266. Resultantly, the

and according to the prescribed quota of Election Commission of Pakistan as shown in the following table.

- f) PC Fatah Katta, PC Ahmed Pur Lamma, PC Wahid Bukhsh Maher of Q.H. Ahmed Pur Lamma should be excluded from PP-265 and included in PP-267 because these are the populations of City area and should be part of urban Constituency. Resultantly, all the urban population/ locality would be in same constituency.


