Memorandum / Objection Petition Against the preliminary Delimitation / Draft of Constituencies No. PP-266 to PP-267 District Rahim Yar Khan Province Punjab Published by the election Commission of Pakistan, Islamabad.

Respectfully Sheweth,

1. That the petitioner is resident of R/O Chak No. 186-P, Tehsil Sadiq Abad District Rahim Yar Khan, CNIC No. 31304-1183830-7, Cell No. 0303-7655685 and is registered voter on Serial No. 276, Gharana No. 98, Census Code: 253070804 in District Rahim Yar Khan in Constituency No. PP-266 Rahim Yar Khan, Vote Certificate is attached here with as Annexure A.
2. That the Preliminary delimitation / draft published by the Election Commission of Pakistan is against the Law, Rules, Province Sections, and Guide Lines Lad Down in the Delimitation Rules and Act 2017.
3. That the preliminary delimitation of constituency No. PP-266, to PP-267, District Rahim Yar Khan is against the Laws, Rules, Principles, Provision Sections, so is Liable to be rectified , modified and revised under the grounds.

GROUND

1. That the Patwar Circles No. I. Chak No. 186/P, No. II. Chak No. 236/P No. III. Chak No 261/P, Tehsil Sadiq Abad have been included in PP 267

2. That the Patwar Circles No. I. Chak No. 186/P, No. II. Chak No. 236/P No. III. Chak No 261/P, Tehsil Sadiq Abad are most closed nearest and adjacent to PP-267 Rahim Yar Khan, but these PCs have been included in PP-266, where as its inclusion into PP-266 is liable to be rectified modified as revised.
 3. That the population of all three PSc Patwar Circles No. I. Chak No. 186/P, No. II. Chak No. 236/P No. III. Chak No 261/P, Tehsil Sadiq Abad are liable to included in PP-267 = 267
 4. That while delaminating both the constituencies, the Election Commission of Pakistan has violated, negated and deviated the golden and principles delimitation and the arrears of all two constituencies have been delimited with the wrong Rules i.e both the constituencies have been delimited from east to west. Whereas the delimitation must be taken from North to South.
 5. That with the exclusion of population of Patwar Circles No. I. Chak No. 186/P, No. II. Chak No. 236/P No. III. Chak No 261/P, Tehsil Sadiq Abad the Compactness of Arrears , Existing Boundries, Common Sources of Communication and in the public convenience and public interest both the constituencies become very ideal and comfortable.
 6. That all three PCs Patwar Circles No. I. Chak No. 186/P, No. II. Chak No. 236/P No. III. Chak No 261/P, Tehsil Sadiq Abad are very closed to PP-266 and the source of Irrigation is common with the other arrears of PP-266 as well as the Road and the Bus Stop along with other infrastructures i.e hospital, Schools, Business Centre and other common sources of communication of affiliated with the constituency No. 267 - 267
 7. That the population data is attached herewith as Annexure-B, through which the Population all three PCs Patwar Circles No. I. Chak No. 186/P, No. II. Chak No. 236/P No. III. Chak No 261/P, Tehsil Sadiq, which is proposed to be include in PP-266 with attached herewith.
 8. That the proposal of the petitioner is just in accordance with the Rules, Porvision, Sections, Guide Lines, Lad Down in the Delimitation Rules, Act 2017 Which is as under

PROPOSAL

- I. That the arrears of all three PCs Patwar Circles No. I. Chak No. 186/P, No. II. Chak No. 236/P No. III. Chak No 261/P, Tehsil Sadiq, be excluded from PP-~~266~~ and to be included in PP-~~267~~ Rahim Yar Khan.
- II. That the proposed map is attached herewith as Annexure-C
- III. That other constituencies of District Rahim Yar Khan are not in to Question.

PRAAYER


