Representation relating to PP 51-PP 53-PP 54-PP-55 PP 58-PP 59-PP 60 & PP62 of District Gujranwala under section 21(2) of election act 2017 read with rule 12 of the act, on behalf of Ch. Muhammad Iqbal s/o Sultan Ahmad, caste Gujjar r/o Theeri Sansi G.T Road, Gujranwala, CNIC No: 34101-2436777-1, Dist. Gujranwala.

The petitioners submit as under:-

1. That the petitioners are the voters of P54 and PP59 hence they are entitled to file the instant petition the photo copies of ID cards and extract of the electoral role are attached

OBJECTIONS

- 1. The PP59 is an odd shape constituency as notified in the preliminary list of constituencies. The map attached with the petition as notified with the commission is evident of this fact that this constituency is not in a compact shape of block this odd shape constituency is not in accordance with the principle under section 20 of the election act 2017 read with rule 12 of the act.
 - Sansra Goraya patwar circle consist upon villages Sansra Goraya,
 Muslim Chak, Qila Mala Sing, Qila Chand and Theeri Sansi.

This patwar circle has been devided into three provincial constituencies. Sansra Goraya, Muslim Chak and Qila Mala Sing have been made part of pp59 where as Qila Chand has been made part of pp55 where as Theeri Sansi has been made part of pp54 against the spirit of Rule 10 of delimitation act 2017. Patwar circle the basic unit has been broken.

- II. Villages Qila Chand and Theeri Sansi Patwar Circle Sensra
 Goraya may be made part of pp59 instead of pp55 and 54
 respectively
- III. Another village Piplli Wala has been made part of pp62 which is not contiguous to pp62 and is far away from its proposed boundries of pp62, this village is contiguous to pp59 and is its natural part
- IV. Village Sheikh Rajada has been made part of pp58 which is also not contiguous to boundries of pp58 and the same is very much contiguous to pp59
 - V. Village Aroop patwar circle has been made part of pp59 which is part and parcel within the boundaries of municipal corporation gujranwala and vey much contiguous to pp53 but this village has wrongly been made part of pp59 and the same be excluded from this constituency.
- 2. That villages Kot Noora, Adil Ghar, Darvaishkay, Vayan Wali falls in circle kanugo Ghakhar tehsile Wazirabad and are integral part pp51 but

have been wrongly and in violation of section 21(2) of election act 2017 read with rule 12 of the said act. Administrative revenue unit has been broken. These villages be withdrawn
