Respectfully Sheweth:

1. That the petitioner is a registered voter of Union Council

(UC). No. MCG 40 and the same UC is the part of PP-57 of

city Gujranwala. The petitioner is the expected candidate from PP-57 Gujranwala.

2. That as per notification No F8(3)2018 Ele-1 Dated 5th of March 2018 , mentioning the above said union council falls in preliminary report of the list of constituencies of provincial (PP-57) and nation assembly (NA-82).
3. That the election commission Pakistan and the delimitation committee constituted by the election commission of Pakistan was bound to follow the principles as described in section 20 of the election act 2017 for the delimitation of constituencies for both national and provincial assembly, which is reproduced as under;

20. Principles of delimitation—(1) “All constituencies for general seats shall, as far as practicable, be delimited having regard to the distribution of population in geographically compact areas, physical features, existing boundaries of administrative unit, facilities of communication and public convenience and other cognate factors to ensure homogeneity in the creation of constituencies”

4. That the delimitation of constituencies in Gujranwala district is of great importance as any unfair practice shall question the whole electoral process negatively, since the initially delimited Provincial constituency PP-57 is almost

15 km meter long and consists upon 21 union councils which is unjust and unfair u/s 20 of the election act 2017.

5. That the following principles are to be followed while finalizing the delimitation of constituencies u/s 20 of the election act 2017.
 - (i) Distribution of population in geographically compact areas.
 - (ii) Physical features.
 - (iii) Existing boundaries of administrative units.
 - (iv) Facilities of communication and public convenience.
 - (v) Cognate factors to ensure homogeneity in the creation of constituencies.

6. That the delimitation plan of the constituencies of city Gujranwala according to the report of delimitation committee is attached herewith as Annexure-A.

7. That the preliminary delimitation of the constituencies published by election commission Pakistan will cause serious inconvenience to the public of the city Gujranwala.

8. That the petitioner is aggrieved by the new delimitation plan and seeks proposed delimitation in PP-57 and others Provincial constituencies of city Gujranwala on the grounds as under;

Grounds

- 10/01/2018*
- (i) That the new delimitation as published in preliminary report and preliminary list is against the provision of section 20 of the election act, 2017 read with rule 10 & 12.
 - (ii) That the election commission of Pakistan has delimited PP-57 in such a way that the length of the constituency has become 15 km long which covers few areas unnecessarily which are naturally linked with PP-55 in respect of physical features and existing boundaries of administrative units. These areas had never been part of PP-57.
 - (iii) That the population required for a provincial constituency to demarcate a provincial constituency as per relevant population census could be retained by bringing minor changes in the charges of PP-57 Gujranwala.
 - (iv) That as per proposed delimitation, suggested PP-57: Gujranwala and others are as under;

9. That the delimitation of constituencies has not been done as mentioned in rule 10 (5). It starts from the northern side of the city and ends at the eastern side of the city which is against the rules stated above. According to the proposed plan the constituencies of the provincial assembly shall remain as may be practicable to the quota and convenience to the public at large.
10. That it is considered that census blocks are indivisible in order to form new provincial or national constituencies and if done so that would be the sheer violation of rules and regulations.
11. That it is humbly submitted that the delimitation of constituencies may be in accordance with the submitted proposed plan based on the solid reason
12. That the above said submissions are according to the principles of the natural justice and fair play and also in

accordance with the Section 20 & 21 of the election act 2017

13. That if the constituencies are not delimited as per proposed
plan the voters of city Gujranwala will be seriously
prejudice and got irreparable loss which will sabotage the
principle of justice and fair play.
