It is very humbly submitted that the petitioner is resident of village Bosal Patwar Circle Bosal QH Bosal of Tehsil Malakwal District Mandi Bahaddin having CNIC No. 34403-1949812-9. The petitioner is a registered voter and his vote No. 812 is registered in voter list of census block No 176020108 of village Bosal which is situated in Patwar Circle Bosal and QH Bosal Tehsil Malakwal District Mandi Bahauddin.

It is stated that the QH Bosal of Tehsil Malakwal was included in old PP-119 which has been substituted as PP-67, M.B.Din-III in the preliminary Delimitation published/ notified by the Election Commission of Pakistan. But in preliminary delimitation, QH Bosal except two Patwar Circles namely Khai and Gohar have been included in PP-68, M.B.Din-IV which is not according to the ground realities and the will of voters of QH Bosal. On behalf of the general public of QH Bosal, the petitioner is submitting this request before your good honour to revise the preliminary delimitation of constituencies PP-67, M.B.Din-III and PP-68 M.B.Din-IV according to the will of the residents of QH Bosal. According to the proposal submitted above there is a minor change occurred. There is no variation of population involved by implementing this proposal and there is no geographically impact. The population remains intact and the compactness of both the constituencies remains intact. Both the constituencies remain in the same NA constituency i.e NA-86, M.B.Din-II. Only the following changes are involved in the proposal:-

- 1. QH Bosal of Tehsil Malakwal is proposed to be excluded from PP-68, M.B.Din-IV and to be included in PP-67, M.B.Din-III. (Two Patwar Circles namely Khai and Gohar of QH Bosal have already been included in PP-67, M.B.Din-III in preliminary delimitation.
- 2. QH Kuthiala Sheikhan except PCs Kuthiala Sheikhan and Aidal are to be excluded from PP-67, M.B.Din-III and is to be included in PP-68, M.B.Din-IV in replace of QH Bosal.

Except the changes submitted above, there is no change is involved in any constituency of National Assembly and other constituencies of Provincial Assembly of District Mandi Bahauddin. As per request/ petition submitted by the petitioner, proposal for the complete District is submitted as under:-
