Subject: **RE-PRESENTATION UNDER RULE-12 OF THE ELECTION
RULES, 2017 (THE RULES) READ WITH SECTION 20 OF
THE ELECTION ACT, 2017 CHALLENGING THE
PRELIMINARY PROPOSAL OF PP-77 (SARGODHA-VI)
AND PP-78 (SARGODHA-VII).**

1. The instant representation is being filed by Rizwan Nowaiz Gill hereinafter referred to as applicant Voter No. 556 of PP-77 (Sargodha-VII). The applicant is duly competent to file the instant representation under the law.
2. That through this representation the applicant seeks to change delimitation proposal published by the Election Commission of Pakistan (hereinafter referred ECP) pertaining to the delimitation of PP-77 Constituency Sargodha-VI and PP-78 Constituency Sargodha-VII hereinafter referred as preliminary proposal which was provided by the Election Commission of Pakistan.
3. That maps of preliminary proposal provided by ECP is also attached as **Annexure-A**.
4. That proposed Map of delimitation for PP-77 and PP-78 is also attached with application for reference and attached as **Annex-B**.

5. OBJECTIONS:

- a. That charge 14 was part of PP-78 (previously PP-34). That without any justification Charge-14 is detached from PP-78 and included with PP-77.
- b. That PC Derehama and Sargodha-I is included with PP-78 where as the said area has no road link with PP-78. PC Derehama and Sargodha-I is geographically attached with PP-77 (previously PP-33). Therefore, to approach the said area one has to cross whole PP-77 and moreover no direct road link with said area for PP-78.
- c. That Sargodha-1 and PC Derehama has attached boundaries with PP-76, therefore, Sargodha-1 and PC Derehama shall be included with PP-76 and Sargodha-2 shall be included with PP-77. It is pertinent to state that Sargodha-2 has geographical compactness with PP-77 and Sargodha-1 and PC Derehama is geographical attached with PP-76.

6. SUGGESTED AMENDMENTS IN THE PRELIMINARY PROPOSAL:

Keeping in view the above objections I propose the following area and population shall be included in PP-77 Sargodha-VI

d. Sargodha-2	75730
e. Charge-14	33696
