Under Section 21 (3) Elections Act 2017 Read with Rule
12 & 13 of Election Rule 2017.

For alterations or modification and readjustment of
PP- 97-I Faisalabad, PP-108-XII, PP-109-XIII, PP-110-
XIV District Faisalabad.

Respectfully Sheweth:

1. That the petitioner is presently registered voter of PP-97
Faisalabad District.
2. That notification No.F8(3)2018-Elc-L dated 05th March
2018 the whole constituencies changed and divided into
the four Provincial Assemblies constituencies without
petitioner knowledge in preliminary report of list of
constituencies of National and Provincial Assemblies.
3. That the petitioner is aggrieved by the new delimitation and
seeks proposed delimitation in PP-97, PP-108, PP-109 and

PP-110 without bring any major changes in the said constituencies of District Faisalabad under the following amongst other:-

Grounds

- i. That the new delimitation of PP-97, PP-108, PP-109 & PP-110 as published in preliminary report ad preliminary list is against the provision of section 20 of Election Act 2017 read with Rule 12 of Election Rule 2017.
- ii. That the election commission of Pakistan and the delimitation committee constituted by the delimitation process of PP-109 as divided in such a way that has adjusted Circle 11 charge 10 Chak No.119 J.B Samana and Rasoolpur in PP-110 and also adjusted Patwar circle Chak No.196 R.B. (East, West) and Chak No.117 J.B Dhanola of Gatwala Kanago Halqa in PP-97 and excluded the said areas from PP-109 (former PP-64).
- iii. That the exclusion of the above said circle 11 charge 10 and Patwar circle of Chak No.196 R.B of Qanogo Halqa Gatwala totally disturb the compactness, physical feature, existing boundaries of administrative unit, facilities of and public, cognate factor to insure homogeneity in the creation of constituencies.

- iv. That the in-collusion of above said area in PP-97 and PP-110 are totally against the principle of lesser disturbance of old constituencies.
 - v. That by the exclusion of circle 11 of charge 10 MC Faisalabad and Patwat Circle Chak No.196 R.B of Gatwala Q.H totally disturbed the public at large and totally unjustified and totally against the spirit of Section 20 (3) of the limitation. It is pertinent to mention that the said areas were remained part and parcel of PP-109 (former PP-64) since 2002 and in delimitation of 2002 the said areas are remained the part of PP-109 (former PP-64) as by the inclusion of the said area compactness of the area and convenience of the public at large and also met with the sprit of section 20 (3) of the election act 2017.
 - vi. That delimitation committee totally ignored the principle of delimitation while delimit PP-109, according to the rule 10-5 of election rule 2017 the delimitation of constituencies shall start from the northern of District, are the case be the agency and then proceed clock wise and zig zag manner keeping in view the population among the constituencies shall remained as closed as many be practicable to the quota. Hence the requirement of law has been over looked in the delimitation done by the commission.
 - vii. That it is settled law that the Census circle should be divided and effecting of the constituencies, whereas, the same has been done against the procedure laid by the law.
 - viii. That as per delimitation notified of 5th March 2018 as the area of PP-97 (former 51) PP-108 (former PP-63), PP-109 (former PP-64), & PP-110 (former PP-65) have been

added and excluded without any justification and totally against the principle of, that the old constituencies should be less disturbed.

- ix. That a table of delimitation published on 5th of March 2018 is given below along with the population.
