MEMORANDUM / OBJECTION PETITION
AGAINST THE PRELIMINARY DELIMITATION /
DRAFT OF CONSTITUENCIES NO. PP-103 & PP-
104, DISTRICT FAISALABAD PROVINCE
PUNJAB PUBLISHED BY THE ELECTION
COMMISSION OF PAKISTAN, ISLAMABAD

Respectfully Sheweth,

1. That the Petitioner is resident of P.O Khas, Chak No. 455-GB, Jhok Hasooki, Tehsil Tandla Wala, District Faisalabad and is enrolled voter to constituency No. PP-103, Faisalabad.
2. That the Election Commission of Pakistan has published the preliminary delimitation / draft of all constituencies of District Faisalabad through a Public Notice.

3. That the delimitation of constituencies PP-102, PP-103, PP-104 & PP-105 District Faisalabad formulated by the Election Commission of Pakistan is just the violation of all the principles, Rules, Sections and provisions laid down by the Delimitation Act 2017, as well as the Delimitation Rules 2017. The map of preliminary delimitation of all constituencies is attached herewith as Annexure-A.
4. That the District Faisalabad has lost one Provincial Assembly Seat as the total population is 78,73,910 according to latest census conducted in 2017. The delimitation of constituencies in Faisalabad has got great importance as any unfair practice shall question the whole electoral process negatively.
5. That the following principles are to be followed while finalizing the delimitation of constituencies Under Section 20 of the Delimitation Act 2017.
 - i. Distribution of population in geographically compact areas.
 - ii. Physical features.
 - iii. Existing boundaries of administrative units.
 - iv. Cognate factors to ensure homogeneity in the creative of constituencies.
6. That the Qanoongi (QH) of Garh which is compact area has been distributed in two provincial constituencies i.e. PP-103 & PP-104 without considering the ground realities and inconvenience of the voters of the vicinity. That all the ground and business contacts of the peoples of Garh QH are attached with Mamu Kanjan which is our Sub Tehsil. All the revenue, food, and NADRA office are in Mamu Kanjun. It is proposed that three PCs (456-GB, 452-GB and

540-GB) of QH Garh which population is almost ~~62733~~ may be excluded from PP-103 and included to PP-104. The same population of QH Mureedwala (PCs 216, 482, 205, 209, 212) which are the part of Tehsil Samundri are included in P-105 and by doing this all the four provincial constituencies PP-102, PP-103, PP-104 and PP-105 will be equally distributed without incurring any inconvenience to any body and this will not adversely effect any voter of the constituency and the proposed plan is attached with the petition.


