Respectfully Sheweth:

1. That the petitioner is presently registered voter of PP-109 Faisalabad District (PC-39/J.B).
2. That notification No.F8(3)2018-Elc-L dated 05th March 2018 the whole constituencies changed and divided into the four Provincial Assemblies constituencies without petitioner knowledge in preliminary report of list of constituencies of National and Provincial Assemblies.
3. That the petitioner is aggrieved by the new delimitation and seeks proposed delimitation in PP-108 without bring any major changes in the said constituencies of District Faisalabad under the following amongst other:-

Grounds ✓

- i. That according to the delimitation PC-39 of Narwala Q.H Tehsil Sadar Faisalabad included in PP-109 without any justification, whereas, PC-35 of Narwala Q.H retained in PP-109.
- ii. That the inclusion of PC-39 and retention of PC-35 in PP-109 create great hardships to the public at large of PC-35 and PC-39.
- iii. That being aggrieved petitioner proposed the amendment / modification in the delimitation of PP-108 Faisalabad XII. The preliminary table of delimitation according to the notification of 5th March 2018 is as under:-

a. Thikriwala Q.H Tehsil Sadar Faisalabad.

b. Patwar circle Chak No.69/J.B of Narwala Q.H of Faisalabad Sadar Tehsil of Faisalabad District

Total Population 3,59,471

The proposed delimitation plan of PP-108 Faisalabad XII is as under:-

a. Thikriwala Q.H Tehsil Sadar Faisalabad.

Population 3,46,329

b. The followings PCs of Narwala Q.H of Tehsil Faisalabad.

i. P.C Chak No.69/J.B 13,142

ii. P.C Chak No.35/J.B 13,810

iii. P.C Chak No.39/J.B 12,626

Total Population 3,85,907

- iv. That PC 35 and PC 39 are adjoined and close to the PP-108 and inclusion of the same PCs in PP-108 is in the

interest of Public at Large, compactness of population, and more convenient to the public at large of said PCs.

- v. That by inclusion the said PCs in PP-108-XII Faisalabad. the population requirement census could be retained by bringing minor changes.
- vi. That Copy of maps of preliminary delimitation and proposed delimitation are attached as annexure "A,B & C" for kind perusal of this Honourable Commission.


Under the above mentioned circumstances, it is humbly prayed that the proposed alteration and modification may please be accepted and PC 35 and PC 39 of Narwala Q.H may kindly be included in PP-108 and adjusted the same in PP-108-XII and exclude the same from PP-109-XIII Faisalabad.

Any other relief which the Honourable deems appropriate fit may kindly also be awarded.
