3. That the delimitation of constituency PP-117 Municipal corporation Faisalabad formulated by the Election Commission of Pakistan is just the violation of all the principles, Rules, Sections and provisions laid down by the Delimitation Act 2017, as well as the Delimitation Rules 2017. The Map of Preliminary delimitation of all constituencies of Municipal corporation Faisalabad is attached herewith.
  4. That the Preliminary delimitation constituency No.117 of Municipal corporation Faisalabad is against the Law, Facts, Rules, Procedure, Principles and Provision as well as sections laid down in Delimitation Act 2017 and is liable to be rectified.

## GROUNDS

- (I) That the District Faisalabad Consisting upon 13 Rural and 8 Urban Provincials Constitutes of Province Punjab bearing constituency No, PP-110 to PP-117 Municipal Corporation Faisalabad and the Petitioner as well as other effects belong to the Provincial Constitutes of Municipal corporation Faisalabad.
- (II) It seems that the almost 33 city councils of Municipal corporation Faisalabad has been added in this constituency. you can see the division on yours Govt. Map which looks very odd and unethical. No any other constituency is like this constituency. Our Election Commission added many areas from 5 others constituencies in it deliberately.
- (III) Many areas are removed from this Constituency which is the center part of this Constituency and many areas are added in this Constituency which is far away from its center point without any solid reason.
- (IV) The Election Commission added many areas which were never being the part of this Constituency. Many Roads and Boundaries of area are not kept in mind during the time of its Division.

## OBJECTIONS & PROPOSALS

1. Remove or Delete these Censes Charges Nos, 14964,14915,14916,14926, from this Constituency No,PP-117 Faisalabad
2. Add These Censes Charges Nos, 14968,14912,14904.
3. Geographically the division is immoral and unethical
4. Remove the uneven areas of PP-110,PP-111,PP-112,PP115,PP-116,which are deliberately added in PP-117.
5. Its is the largest City Constituency which is not acceptable for us. The Population of PP-117 is 3,91,388
6. Voters are confused by the Division of this Constituency.

### PRAYER:

The alternate change which I have recommended for PP-117 will be Helpful for Both i.e Candidates and Voters to contact each others Geographically and compatibility with problems as well as helpful for Election Commission of Pakistan for preparing Poling Schemes for PP-117.

I hope you will correct the Division of this Constituency PP-117 as I have explained in details which will meet Legal, Moral and Political Requirements.

In the circumstances mentioned above it is humbly prayed that PP-117 may kindly be delimited and formulated with the exclusion and inclusion of populations in this lights of proposed MAP of the Petitioner along with the proposed populations mentioned in the population distribution /Data by the petitioner in the best of the public of the area of PP-117.
