5. That it is in the fitness of the circumstances to allow the applicant to become the party in the lis and / or the Applicant be given the right of audience while hearing the representation.


Prayer:

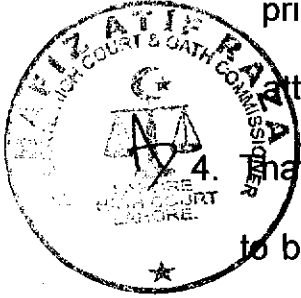
