For alterations/modification and readjustment of PP- 124 Jhang-I PP-125 Jhang-II PP-127 Jhang-IV PP-128 Jhang-V PP-129 Jhang-VI PP-130 Jhang-VII District Jhang.

Respectfully Sheweth:

- That the petitioner is presently registered voter of PP-129
 Jhang-Il District Jhang.
- That notification No.F8(3)2018-Elc-L dated 05th March
 2018 the whole constituencies changed and divided into the four Provincial Assemblies constituencies without

petitioner knowledge in preliminary report of list of constituencies of National and Provincial Assemblies.

3. That the petitioner is aggrieved by the new delimitation and seeks proposed delimitation in PP-124, PP-125, PP-127 PP-128 PP-129 and PP-130 District Jhang without bring any major changes in the said constituencies of District Jhang under the following amongst other:-

Grounds

- i. That the new delimitation of PP-124, PP-125 PP-127, PP-128 PP-129 & PP-130 of district Jhang as published in preliminary report ad preliminary list is against the provision of section 20 of Election Act 2017 read with Rule 12 of Election Rule 2017.
- ii. The exclusion of following patwar circle of Meernay Wala QH, Tehsil Ahmad Pur Sial, Hassu Bulail PC, Bahrh Gharbi PC, Fatah Pur Pirti PC and Islam Pur Nashaib from PP-125 Jhang totally against the principal of lesser disturbances of old constituencies and also ignored that by exclusion of said areas totally disturb the compactness, physical feature, existing boundaries of administrative unit, facilities of and public, cognate factor to insure homogeneity in the creation of constituency. It is pertinent to mention that there

is no road approach towards PP-129 as the said patwar circle are situated between the river and there is nor road access towards the other abadies of PP-129 from Fatah Pur Priti and other Patwar Circle mention in para supra.

- That the election commission of Pakistan and iii. delimitation committee constituted for Punjab, in the delimitation process of PP-125 in such a way and included massan QH of tehsil Jhang without the considering the basic spirt of section 20 of election Act 2017 red with rule 12 of election rule 2017 without any justification and without observing the grounds realties. It is pertinent to mention the people/voter member of QH Massan by inclusion of Massan QH in PP-125 Jhang-Il are likely to face great hardship, problem and in-convinces as there is no road access, passage, existed to approach PP-125 as QH Massan situated between the two river and more than 100 Kilometers distains between the Massan and other abadies of PP-125 and only way of transport available by river which is very dangerous for life.
- iv. That inclusion of Massan QH in PP-125 Jhang-Il totally disturb the compactness, physical feature, existing boundaries of administrative unit, facilities of and public,

cognate factor to insure homogeneity in the creation of constituencies.

- v. That the Patwar circles of Meernay Wala QH mentioned in above said para excluded from PP-125 and included in PP-129 and PP-130 is against the basic policy of delimitation and also against the basic principal of rule 10 (5) of election rules 2017, as delimitation of constituencies shell start from northern of district, are case be the agency and than proceed clock wise and zig zag manner keeping in view the populating among the constituencies shell remained as close as may be practicable.
- vi. But the delimitation committee totally over look the requirement of law in this regard.
- vii. That it is settled law that the Census circle should be divided and effecting of the constituencies, whereas, the same has been done against the procedure laid by the law.
- viii. That as per delimitation notified of 5th March 2018 as the area of PP-124 PP-125 PP-127 PP-128 PP-129 & PP-130 have been added and excluded without any justification and totally against the principle of, that the old constituencies should be less disturbed.
- ix. That a table of delimitation published on 5th of March 2018 is given below along with the population.
