**SUBJECT MATTER: OBJECTION PETITION AGAINST THE PRELIMINARY DELIMITATION PROPOSALS OF PP-131 & 132 OF TEHSIL SHAHKOT, DISTRICT NANKANA SAHIB UNDER RULE 12 OF ELECTION RULES, 2017.**

Respectfully sheweth:

1. That the petitioner is a registered voter of the Union Council-11 Kariwala of Chak No.50/R.B. Tehsil Shahkot District Nankana and his name is duly reflected in the concerned voter list at serial No.329. Copy is attached herewith. *y NA 117 Nankana Sahib*
2. That the Provincial Assembly 132 was formally known as PP-171 but after the recent consensus, the same has been delimited and divided into two constituencies i.e. PP-131 and PP-132 by the Delimitation Committee, Punjab.
3. That PP-131 and PP-132 have been proposed by the Delimitation Committee Punjab as follows;  
**PP-131:** (a) Sangla Hill Tehsil  
(b) The following PCs of QH, Shah Kot of Shah Kot Tehsil
  - i) Chak No.26/RB
  - ii) Chak No.44/RB
  - iii) Chak No.48/RB
  - iv) Chak No.50/RB

- v) Chak No.80/RB
  - vi) Chak No.168/RB and
  - vii) Chak No.176/RB of District Nankana Sahib
- Total population 337,304/-

**PP-132:**

- (a) MC Shah Kot
  - (b) Shah Kot QH of Shah Kot Tehsil excluding the following PCs
    - i) Chak No.26/RB
    - ii) Chak No.44/RB
    - iii) Chak No.48/RB
    - iv) Chak No.50/RB
    - v) Chak No.168/RB and
    - vi) Chak No.176/RB
  - (c) MC Warburton of Tehsil Nankana Sahib
  - (d) The following QHs of Tehsil Nankana Sahib

4. That the petitioner proposes the following re-adjustment in above proposals of Delimitation Committee regarding PP-131 and PP-132 of Tehsil Shah Kot, District Nankana Sahib, whereas the petitioner does not want any changes in the composition of National Assembly Constituencies of the District.

**PP-131 Nankana Sahib-I**

- a) Sangla Hill Tehsil
- b) The following PCs of QH Shahkot of Shah Kot Tehsil
  - i) Chak No.26/RB
  - ii) Chak No.48/RB
  - iii) Chak No.80/RB

- iv) **Chak No.166/RB**
- v) Chak No.168/RB
- vi) Chak No.176/RB and
- vii) **Chak No.177/RB of Tehsil Shahkot, District Nankana Sahib**

**PP-132 Nankana Sahib-II**

- a) MC Shahkot
- b) Shahkot QH of Shahkot
  - i) **Chak No.50/RB**
  - ii) **Chak No.44/RB**
- c) MC Warburton of Tehsil Nankana Sahib
- d) The following of Tehsil Nankana
  - i) Mohlan
  - ii) Warburton

- e) That Circle No.44 (Chak No.39/RB and Chak NO.49/RB, 50/RB & 51/RB) are proposed to be withdrawn from PP-131 and be included in PP-132.
- f) That Chak No.177 & 166 need to be withdrawn from PP-132 and included in PP-131 due to the close proximity to Chak No.176 and Chak No.168.
- 5. That the petitioner seeks the above re-adjustment in PP-131 and PP-132 on the following amongst others grounds;
  - a) That the proposed delimitation of PP-131 and PP-132 of Tehsil Shahkot, District Nankana by the delimitation Committee Punjab is violative of the principle of delimitation as contemplated in Chapter III section 20 of Election Act, 2017 regarding the principles of delimitation.

- b) That the proposal of delimitation committee regarding PP-131 and PP-132 is against the principles of facilities of communication and public convenience.
- c) That the proposal of delimitation committee is also against the principles of distribution of population in Geographical compact area.
- d) That the delimitation of PP-131 and PP-132 by the delimitation Committee Punjab seems to be irrational in its geographical existence as PP-131 consist of 16-17 KM area almost within one administrative unit, whereas PP-132 consist of 41 KM area under two administrative units.
- e) That it would be very difficult for the contesting candidates to approach the voters and he has to cross through Tehsil Shahkot, Manawala Ferozewatwan Warbton District Shekhupura, if he wants to approach the voters residing in the tale.
- f) That due to the physical and geographical division of PP-131 and PP-132 level playing, field will not be available for the contesting candidates of PP-132.
- g) That the proposed re-adjustment shall not entail any disturbance in the rest of constituencies of the district as the proposed re-adjustments are reciprocal in nature.
- h) That there would no major disturbance in population in both the constituencies and the minor changes of population of about 15000 voters are much within the limit of plus minus 10,000.

#### **ADVANTAGES**

1. That if the above proposals are accepted and re-adjustments suggested are made, it would reduce the total length of PP-132 by 8 to 9 KM.
  - a) That the general interest of the voters would be better safeguarded.
  - b) That the voters of Chak No.50/R.B. which infact situates in Tehsil Shah Kot would be saved from the agony of protracted


journey of 20 Kilometers to Tehsil Sangla Hill for their basic issues.

- c) It would reduce the hazards of division of one U.C. into two constituencies.
- d) That the division and distribution of Chak No. 85 and 44/R.B. were already part of the same Union Council, the rejoining and reassembling of these villages who are in closed proximity with each other would definitely minimize the problems of inhabitants of the locality.
- e) That Two MPAs' of the same U.C. would affect the basic issues and the developmental projects of the locality / people and if the proposed re-adjustments are made it would eliminate the stated hazard.
- f) That if the suggested re-adjustments are made, it would not affect and disturb the entire district and the composition of its National Assembly Constituencies.

In view of the above proposals, it is therefore prayed that the proposed re-adjustments suggested by the petitioner for the delimitation of PP-131 and PP-132 of Tehsil Shakot, District Nankana Sahib may graciously be allowed and sanction may be granted for delimitation of PP-131 and PP-132 as proposed by the petitioner, in the interest of voters.
