**BEFORE SECRETARY ELECTION COMMISSION OF PAKISTAN**

**REPRESENTATION AGAINST DELIMITATION OF CONSTITUENCIES SITUATED AT  
SHAIKHUPURA INVITED BY THE ELECTION COMMISSION THROUGH TENDER  
NOTICE**

RESPECTFULLY SHEWETH:

1. That the petitioner is resident of Chak No.23 situated at Tehsil Sharaqpur District Sheikhupura, owner of huge chunk of land in the said area and known personality within the constituency No.138-PP and 139PP. The petitioner is registered voter within the constituency of PP- 139.
2. That the petitioner is aggrieved from delimitation of constituency No PP-138 and PP-139 and these both are required amendment in delimitation. It is further submitted that the other constituencies located in the same districts i.e. No.119-NA, 120-NA, 121-NA, 122-NA, 135-PP, 136-PP, 137-PP, 140-PP, 141-PP, 142-PP, are correct and to this extent there is no objection. The two constituencies mentioned above i.e. 138-PP & 139-PP are required delimitation on the following

**REASONS**

- a. That under the spirit of law delimitation process is required for alterations of voter's area, to avoid imbalance in population area,

to institutionalized participation of people in the elections, to harmonize census blocks and its demographic compactness. In the present case Qanungoi Headquarter of Dhamkay Patwar circle Chak No.19, Patwar circle Chak No.22, and Patwar circle chak No.23 falls under the constituency of PP-139 district Sheikhpura. These chaks are demographically adjacent to the constituency of PP-138, which reasonably are one unit and one compact. The residents/occupants/voters/land owners of PP No.139 for the equalization of votes are required to include in the PP 138. The voters are also used to enjoy the basic facilities i.e. roads, waters channels, canals, bridges, electricity etc of 138-PP constituency. It is material to highlight that three patwar circles mentioned above of 139-PP are situated at the boundary of 138-PP. By inclusion of these three patwar circles with 138-PP it will remove imbalance of the constituencies. It does not cause any effect or disturb any right to the resident of PP-139. Copy of map highlighted with yellow colour is attached for the perusal of this authority.

b. That according to the population and house hold detail the total population of PP-139 was assessed as 3,88,626. In the PP-138 it was assessed as 3,67,039. It is pertinent to mention here that total population of chak No.19 was 2,935, Chak No.22 was 3,335 and Chak No.23 was 4114 total is 10,384. It is submitted that this

number of persons from the constituency of 139 if added in 138 which becomes 3,77,423 it will reduced discrepancy of 2 constituencies i.e. 138 & 139. Even by exclusion of number of person i.e. 10,384 from 139 the population will 3,78,242 more than the from 138-PP. By the proposed delimitation of these two constituencies the residents will be happier and will have more opportunities of facilities. The distribution of funds from the government will also reduce miseries of residents as funds will be appropriately utilized without discrimination by treating as equal holding in the constituencies.

c. That the proposed delimitation shall not cause any effect to the general voters or the politicians. This proposed delimitation is only advised in the interest of general public at large within the said two constituencies. This proposal institutionalized participation of people on equal level. The said proposal further strengthened processes of fair and honest elections which is basic requirement of law. It will discourage discrimination of two constituencies. It will harmonize territorial unity and will not break revenue estate. It also classically avoid principle of Gerrymandering
