That the petitioner is Candidate for Provincial Assembly from PP-167 and Enroled as Register Voter on Electrol Rol Vote No 604 Census Block Code No 185010606 Circle No 6 Charge No 01 Tehsil Lahore City District Lahore Under CNIC No 35202-4347470-9 . As per the notification number FB (3)/2018-ELC-1 dated 15 march 2018. The whole constituency has been changed and divided into different constituencies without his knowledge in preliminary report of the list of constituencies of provincial as well as national assembly. That the under signed is now candidate from PP - 167 Lahore and agrived by the new Delimitations and seekes proposed delimitation in PP-152 and PP-167 without bringing major changes in all above mention constituencies under following amongst other.



G R O U N D S:

- I. That the new delimitations as published in preliminary list is against the provisions of section 20 of election act 2017 read with rule 10 and 12 of elections rule 2017
- II. That the Election Commission of Pakistan during delimitation process of PP-167 , That with out any major changes of in the Boundries of PP-152 and PP-167,The Charge No 59 of Tehsil City Lahore Included in PP-167 and Excluded from PP- 152 Consist Upon Popuation 38027 .Then The Compactness of Census Block will Be Complete.
- III. The Residents of Charge No 59 of The Tehsil City Suffering From Rush of Traffic around the huge and Big Drainage and Crossing they will cast their Votes and if That Charge Included in PP-167 then the residents will cast their votes easily.
- IV. The Delimitation Committee by Violating Election Rules and Election Act 2017 the three Ward of Union Council No 106 Included in PP-152 where as the Rest of the UC 106 Included in PP-167 , and Ignored the Compactness of Census Block/
- V. That as per new delimitation the suggested PP-152 and PP-167 Constituencies in Lahore is as following.

COPY OF MAP PP- 167 LAHORE-XXIV ALONG WITH ALL ABOVE SUGGESTED AND PROPOSED DELIMITATION IS ATTACHED HEREWITH FOR THE KIND PEROSAL OF THIS HONORABLE COMMISSION:

- That the delimitation of all above constituencies including PP- 167 Lahore-XXIV have not been done as mentioned in rule 10(5) of the election rule 2017 according to which delimitation of the constituencies shall be start from the northern of the district or as the case may be the agency and then proceed clockwise in zig zag manner. Keeping in view in that population among the constituencies of an assembly shall remain as close as may be practicable to quota. Hence the requirement of law has been overlooked in the delimitation process by the commission.
- It is settled that census circles should not be divided and broken affecting the basic boundaries of the constituencies whereas the same has been done against the procedure define by the law.
- That as per amended delimitation the area included and excluded have been edit without any justification and by ignoring by ground realities.
- That as per new proposed delimitations structure the distribution of population has been geographically compact area facilitating communication and roads approached with the object of public convenience whereas the suggested delimitation overlooked in the process of delimitations.
