REPRESENTATION UNDER SECTION 21(3) OF THE ELECTION ACT 2017 READ WITH RULE 11 (4) OF THE ELECTION RULES 2017 FOR THE DE-LIMITATION OF THE PROPOSED CONSTITUENCY NO. PP-175 IN THE PRELIMINARY REPORT Respectfully Sheweth:

#### **ABSTRACT**

District Kasur of Punjab has been clock-wise divided into nine (9) provincial constituencies bearing No. PP 174 to PP 182. The instant issue pertains to **CONSTITUENCY PP-NO. 175**;

The <u>Patwar Circle CHAK-BULYANA</u> having population of 21,748 has been included in Constituency PP-No. 174 (City / Urban Kasur), which actually merits to be included in PP-175- Rural on the following grounds:

## **GROUNDS**

- a. There is no population/typographic link of <u>PC-CHAK-BULYANA</u> with Urban Kasur (PP No. 174) as there is a distance of 3 & ½ Kilometers between the inhabitants, which is agricultural land part of "Beiroon-Kasur". PC-CHAK-BULYANA must become part of PP No. 175 due to homogeneity and compactness;
- b. The PC-CHAK-BULYANA is abutting boarder of India on one side and on other three side, it is surrounded by PP No. 175, thus it is an island created within PP No. 175 and hence merits to be included in PP No. 175 according to revenue record; (Annexed)

- c. The PC-CHAK-BULYANA has been wrongly displayed in the Election Commission MAP; as its location exacted in Revenue MAP is different and Revenue Record is to take preference being more long lasting and authentic;
- d. The current population of PP No. 175 and PC-CHAK-BULYANA is given below:
  - i. Population of PP No. 175 = 428, 984
  - ii. Population of PC-CHAK-BULYANA = 21, 748By adding population of PC-CHAK-BULYANA into PP No. 175;

# THE TOTAL POPULATION OF PP No. 175 REACHES TO 450, 732

- e. That according to provisional MAP of ECP the PC-Lakhnaki and PC- Khara, collectively having population of 41, 100 was part of PP No. 182 but in present ECP MAP both aforementioned PC(s) have now been added into PP No. 175.
- f. That three Patwar Circles of PP No. 175 which are abutting bordering PP No. 182 are given under:
  - i. Population of PC-Athel Pur = 21, 485
  - ii. Population of PC-Aurara = 13, 382

iii. Population of PC-Daftuh (Missing in the ECP Map) = 11, 483

Total Population of the three (3) Patwar Circles = 46,

Since the population of PP No. 175 has increased from the basic Quota for province of Punjab (370, 429) with 10% plus minus. It is therefore proposed that if the above mentioned three Patwar Circles collectively having population of 46, 349, are excluded from the PP No. 175 and added to PP No. 182; The Population of PP No.175 Shall come to 404,383, which not only justifies the basic Constituency Quota of Population for the province of Punjab but also the compactness and homogeneity these Patwar Circles justifies their inclusion in PP No. 182 and still further the population of PP No.182 will become 409369 and thus will come closer to the Population of PP No. 175 after inclusion of PC-CHAK-BULYANA.

### PRAYER:

In the light of the above mentioned it is therefore prayed:

a. The Patwar Circle (PC) CHAK-BULYANA be added in PP No.175 and excluded from PP No. 174;

b. The Patwar Circle(s) PC-Athel Pur, PC-Aurara, PC-Daftuh be excuded from PP No. 175 and added into PP No. 182.

Any other relief to which the petitioners are entitled may kindly

be granted in the interest of justice.
