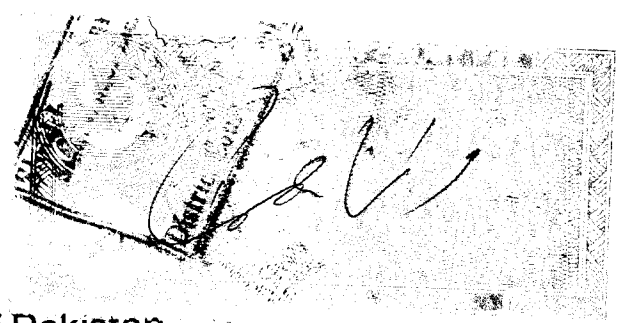

Subject:- OBJECTION OVER DELIMITATION OF  
PROVINCIAL CONSTITUENCY PPC-179,  
KASUR-VI

Respectfully Sheweth:-

1. That the applicant is candidate as Member Provincial Assembly Punjab its Constituency PP-179 Kasur VI.
2. That the voter registration detail of the applicant is as under:-

**Block No. 191090301**  
**Serial No. 389**  
**Area Badar Colony, Tehsil Pattoki District Kasur.**

3. That the applicant received preliminary report regarding list of Constituency specifying the areas proposed to be included in each Constituency along with the map of District Kasur issued by Election Commission of Pakistan.
4. That the applicant has following objections over the delimitation of Constituency PP-179 Kasur-VI.

**Objections**

- a. That during the proposed delimitation of Constituency PP-179 Kasur VI, the area of UC-Sandrus which is the part of parcel of Tehsil Chunian was previously the part and parcel of PP-181 which was presently numbered as PP-178, the said area of UC-Sandrus was included in Constituency PP-179, which area is far flank from Tehsil Pattoki and nearest to Chunian City and falls within the area of PP-178. It is pertinent

to mention here that UC- Sandrus is the area where the residential house of the present MPA is situated. Therefore, the said inclusion of UC-Sandrus in PP-179 is unjustified.

It is astonishingly notable that Patwar Circle Chunian Uthar, which is consisted upon Chunian Municipal Committee and Kot Sandrus was broken, as a result of which the Chunian MC is made part of PP-178, whereas Kot Sandrus is included in PP-179 in drop list of Constituency in the nature of Form-5 of Rule 10(7) of Election Rule 2017 but on the contrary in the map prepared in the light of preliminary report the Delimitation Committee Kot Sandrus appears to be part of PP-178.

That during Election 2013 Kot Sandrus was under the Constituency of PP-181 presently PP-178 & Delimitation Committee while conducting the Delimitation Process ignored this particular material aspect. It is further important to note here that UC Kot Sandrus is a part of Patwaar Circle Chunian Uthar even is not reflected in the Preliminary Delimitation Report prepared and published on 05.03.2018.

- b. That area of Chak No.68 & 68 namely Rak Naroki Maja & Chak No.34 was previously included in the area of PP-182 presently PP-179 and now without any reason and justification the same area was deleted and included in PP-180, which is situated in far flank area and the voters of the area would suffer loss while costing their votes. The majority of

population of Chak No.68 is residing in the Urban Area of Tehsil Pattoki. In case the said area is not included in PP-179 then the most of the population of the said Chak Numbers would suffer loss while costing right of votes.

- c. That according to the Map provided by the Election Commission of Pakistan, the Chak No.36 & 37 are fall in the middle of the said Constituency i.e. PP-179, whereas the said Chaks are shown in the Constituency PP-180. This ambiguity would cause serious prejudice to the population of the said Chaks those are situated in the middle of the area of PP-179 and they were included in PP-180.
- d. That the area of Village Nowshera Mohaar Singh Barwal Khurd was included in PP-179, whereas the said area is nearest to City Chunian which falls in PP-178. It is pertinent to mention here that previously said area was part and parcel of PP-178 and now without any reason and justification included in PP-179, which area no way suits in PP-179 as per its Geographical existence.
- e. That as per Election Act & Rule framed there under no Provincial Constituency exceed the population limits of 04 Lacs, the present population of PP-179 is about 365,800 and through proposed amendments the population meets the requirement of law and becomes to about 04 Lacs.
- f. That in the attached proposed plan, the area wants to be included to in PP-179 is shown with green colour and the area required to be excluded is shown in

Orange Colour and proposed Constituency is shown in Yellow Colour.

- g. That the proposal of applicant regarding delimitations of PP-179 are in accordance with Qanoongo and Patwar Circle Limit, which are within the maximum population fixed for each Provincial Constituency.
- h. That the proposed amendments, alterations, modifications, inclusion and exclusion of areas are very essential to hold fair and free election, which is the basic right of applicant and the sole mandate of the election commission.


**Prayer**

It is therefore, requested that while accepting the above objections, necessary amendments, alternations and modifications regarding inclusion and exclusion of the area be made in Constituency PP-179 Kasur VI alongwith other adjacent Constituencies as proposed by the applicant.
