Subject: **OBJECTIONS OVER DELIMITATION OF PROVINCIAL  
CONSTITUENCY PP-181, KASUR VIII**

Respectfully Sheweth:-

1. That applicant is candidate of member provincial assembly in PP-181, Kasur-VIII. My vote registration detail is as under:-  
Block No.191070203, Serial No.726, Area Mohallah Joyanwala Phool Nagar, Tehsil Pattoki.
2. That applicant obtained preliminary report, list of constituencies specifying the areas proposed to be included in each constituency along with the map of District Kasur.
3. That in the proposed delimitation of this constituency PP-181 Kasur VIII Six Patwar circles Qanungoi Jamber Kalan namely Jamber Kalan, Jamber Khurd, Khan Key More, Phuliani I, II and Haripur are detached from this constituency and are included in PP-180 Kasur VII. Whereas from Tehsil Kot Radha Kishen of Qanungoi Circle I, Patwar Circle Boott, Mudkey Dhariwal, Chak no.55 and Bhagiare Mar are attached with this constituency. This proposal is not fair and is made to satisfy the present member parliamentarians of areas. Thus is current delimitation revenue limits of Tehsil Kot Radha Kishen are badly disturbed as this tehsil is divided in three parts and attached with other three tehsils of district. This is against the prudence of mind and scheme of law.
4. That Qanungo circle Raja Jang is included in PP-182 Kasur IX, whereas two patwar circles Khara and Lakhneki overfly in PP-175 Kasur II. Thus the same is against Election Act and Rules 2017.
5. As per Election Act and Rules 2017 no provincial constituency will exceed to population limit of 4 lacs whereas populations of proposed constituency of PP-182-Kasur IX exceeds from 4 Lacs which is against the law of land. Thus the same is against Election Act and Rules 2017.
6. That in light of objections made in para 3,4 and 5 for the purpose of amendment alteration and modification in the final list of constituencies of District Kasur. I have annexed the proposed list of all constituencies specifying the proposed areas of each constituency along with proposed map of District Kasur as per my proposals for each constituency.
7. That the proposals of applicant regarding delimitations are in accordance with Qanungo and Patwar circles limit which are also



within the maximum population fixed for each provincial constituency, whereas the proposed area of each constituency along with map is against the principles laid down in Election Act. and Rules 2017.

8. That amendments, alterations and modifications proposed by applicant are very assential to hold fair and free election which is basic and sole mandate of The Commission.

It is therefore requested that while accepting these objections necessary amendments, alteration and modification be made in constituency PP-179 Kasur VI along with other constituencies of the Kasur which are proposed by applicant.
