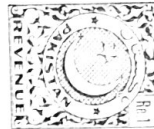
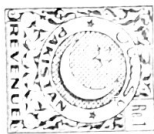

with section 20 of Election Act, 2017 Alongwith Other Election Laws in
respect of the announced de-limitation to the extent of Constituency
PP-180 and PP-181 of Tehsil Pattoki, District Kasur, Punjab.**

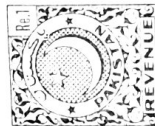
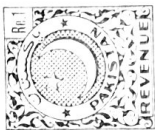
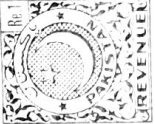
- 1- That the petitioner is a registered voter of the Constituency PP-181, in Electoral Area/ Shamariyati Block Code 191060805, Silsala No. 18, Intikhabi Ellaqa Bagyana Kalan, Tehsil Pattoki, District Kasur.
- 2- That the petitioner has obtained preliminary report, list of constituencies specifying the areas proposed to be included in each constituency along with the map of District Kasur.
- 3- That the petitioner is submitting that the Patwar Circles namely, Jamber Khurd and Jamber Kalan of Q.H. Jamber Kalan are to be excluded from the constituency PP-180 and included in constituency PP-181 because the said Patwar Circles are more closed to the Municipal Committee Phool Nagar almost five kilometres from the

Administrative unit, Phool Nagar. Moreover, said Patwar Circles are also included in the jurisdiction of Police Station Phool Nagar, Sadar and under the supervision of same SDPO, Tehsil Pattoki. If these Patwar Circles would be included in PP-181, there will be no disturbance in terms of population, the map of the constituency as well as District map and it suits in geographically and compactness as per election rules. It is very important to mention here that the above said Patwar Circles (Jamber Sub-Division Wapda) also come under the same Wapda administrative unit with Phool Nagar Wapda Division, therefore, it is important to include these Patwar Circles in PP-181 rather than in the PP-180.

- 4- That, similarly, the petitioner is submitting that the Patwar Circles namely, Bhoey Asal, Gandi Uttar (Q.H. Jamber Kalan), Bunga Madran (Q.H. Phool Nagar) are to be excluded from the Constituency PP-181 and included in the Constituency PP-180. The Patwar Circles namely, Bhoey Asal and Gandi Uttar are far away from the Administrative unit, Phool Nagar and is almost fifteen to twenty Kilometers. Moreover, these two Patwar Circles come under the jurisdiction of Police Station Changa Manga which is situated in the other Administrative unit, Tehsil Chunian. Similarly, these two Patwar Circles are presently part of Kot Radha Kishan West Sub-Division Wapda of Tehsil Kot Radha Kishon, therefore, these two Patwar Circles are not to be part of the constituency PP- 181.

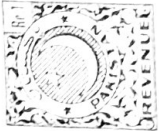
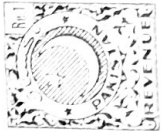
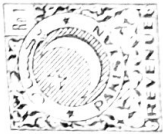

6- That the proposed map, voter form and list of constituencies PP District Kasur are attached with the petition.

7- That the population of the constituency PP-181 which has been announced by the ECP is not matched with the area which has been mentioned in the list given by the ECP. As per the list, the population

of the given area of the Constituency PP-181 is 354985 as per the list whereas, it is mentioned in the list as 382047. The Patwar Circles namely, Bochoki Maja population of 6062 and Rosa Bhail population of 21000 of (Q.H. II of Kot Radha Kishon) have not been mentioned in the given list, if the name of these two patwar circles are included in the given list then the population of the constituency will match with the given population of the said constituency PP- 181 which is 382047. It is found that it is a clerical mistake which would be addressed by the Commission for the interest of justice and fair play.

8- That the proposals which have been submitted by the petitioner above are practicable, distribution of population in geographically compact areas, Zigzag manner, physical features, existing boundaries of administrative units, facilities of communication, local bodies structure, public convenience, cognate factors, and homogeneity in the creation of constituencies i.e. PP-180 and PP-181.

9- That the petitioner may kindly be allowed to submit additional grounds/reasons for the above said proposals at the time of hearing of this representation.



PRAYER:

In view of the above proposed submissions, it is, therefore, humbly prayed the instant representation may kindly be accepted and the provincial constituencies PP-180 and PP-181 of District Kasur be made, in accordance with the proposed map of the petitioner for the interest of public convenience, justice and fair play.
Any other relief which this Committee may think fit also be granted.
