

Sub: REPRESENTATION/OBJECTIONS REGARDING CORRECTION OF
TECHNICAL TYPING MISTAKE IN THE PRELIMINARY
DELIMITATION/DRAFT ISSUED BY THE ELECTION COMMISSION OF
PAKISTAN OF PP 182 KASUR, PUNJAB

- 1. That the applicant Muhammad Akmal is the resident of Tehsil Kot Radha Kishan Distt Kasur, C.N.I.C 35201-4542085-3, registered voter and candidate for provincial assembly of constituency no. PP-182 Kasur Punjab.
- 2. There are two clerical error/difference between map issued by the election commission of Pakistan and description issued by the election commission of Pakistan. In the preliminary draft/report of PP 182 Kasur Punjab, Detail as under.

PP 182 Kasur-IX

- (a) Tehsil Kot Radha Kishan excluding:-
- (1) Kot Radha Kishan-II-QH
- (2) The following of PCs of Kot Radha Kishan.

- (ii) Chak No. 055
- (iii) Baghaiar Mar
- (3) Hallar Ke Paimar PC of Bhamba-I-QH
- (b) Raja Jang QH of Kasur Tehsil
- (c) Raja Jang MC
- 3. That the constituency is liable to be corrected on the following:-

GROUNDS

a. That the preliminary draft of PP 182 Kasur-IX is not according to the map issued by the election commission of Pakistan. There is glaring difference between description and map it is pertinent to mention

here that two Patwar circle (1) Khara and (2) Lakhanake of Raja Jang QH has been included in my constituency having population according to the 2017 censes 41,100. According to the map issued by the election commission of Pakistan. Annexe B, Two Patwar circles" Khara and Lakhneke ara not in accordance with the demarcation line shows on the Map Annexe B. in between there is Patwar circle Aurara which is separating these two Patwar circles. These two Patwar circles are not included in my Constituency according to the demarcation line drawn on the map. Hence these may kindly be excluded. The demarcation line as the map shows Patwar circle of Lakhneke and Khara are included in PP 175 and not 182. Necessary clerical mistake, error may kindly be corrected accordingly

b. Another serious objection to this draft is that the Bhail Patwar circle and Prame Nagar Patwar circle population. Are shown in my constituency of PP-182 Kasur-IX according to the demarcation line drawn on the map issued by the election commission of Pakistan. But there population is not included in my constituency PP-182. It is clerical typing mistake which is kindly be corrected. Bhail Patwar Circle has huge population/voters not including in any constituency of District Kasur or any other constituency which has snatched, disfranchised and violated the fundamental rights to vote of the voters hence the preliminary delimitation may kindly be modified, altered and amended, otherwise the voters will suffer a lot and the same is included in the constituency PP-182.

PRAYER, This is a clerical mistake so it is humbly requested to exclude the Khara and Lakhneke Patwar circle and include Bhail, Prame Nagar Patwar Circle in the description/ draft of constituency PP-182 Kasur-IX.
