Representation Under Rule 10 and 12 of Election Rules, 2017 read with section 20 of Election Act, 2017Alongwith Other Election Laws in respect of the announced de-limitation to the extent of Constituency PP-185, PP-186, PP-187 and PP-188 of Tehsil Depalpur, District Okara, Punjab.

Respectfully Sheweth:

- 1- That the petitioner is a registered voter of the Constituency PP-186, Tehsil Depalpur, District Okara, Punjab in Electoral Area/Sharifabad (Jasoke Dhon).
- 2- That the total population of District Okara are consist of 30,39139 population, as per the census of 2017. The ECP allocated four NA seats and eight PP seats. In accordance with Election laws, there should be population of NA is almost 760000 and PP is almost 380000. The petitioner's proposal, regarding population is, as per the ECP.
- 3- That the petitioner is submitting his suggestion to meet with social structure, communication, irrigation system's commonality and compactness, physical features and homogeneity.

4- That the petitioner is submitting that the Patwar Cirle namely wrongly Allah Munfoolpur) 'JAFARABAD' (Pandat is mentioned/drawn/marked in the announced map by the election commission of Pakistan, basically the said patwar circle is adjacent to Ladewal Patwar Circle in North, Mari Comboh Patwar Circle in South, Sharifabad (Jasoki Dhon) in West and Bunga Saleh in East but it had not been shown in the map issued by the ECP.

Constituency PP-185:

- a- That the Election Commission of Pakistan (ECP) had announced Constituency PP-185 and the petitioner is objecting the Delimitation of the said constituency to the extent of three Patwar Circles namely, Lalewala (Q.H. Depalpur II), Rajuwal (Q.H. SherGurh) and Qila Dewan Singh (Q.H. Shergurh) and is requesting to include the said three Patwar Circles in Constituency PP-187 because the people of the Constituency PP-187 will have easy access to the main road of Lahore to Pakpattan.
- b- The petitioner is proposing to include three Patwar Circles namely, Mahtabwal, Qila Juwandsingh and 38-D (Q.H. Depalpur I) because the Constituency PP-185 will have a direct access to Okara to Depalpur main road. These Patwar Circles have common irrigation system, local body system and homogeneity.

Constituency PP-186:

a- That ECP had announced the delimitation of PP-186. The petitioner is objecting the delimitation of the Constituency PP-186 to the extent of three Patwar Circles namely, Mahtabwala, Qila Jovand Singh and 38-D and the said three Patwar Cirles may kindly be included in the Constituency PP-185. Main road from Tehsil headquarter Depalpur to District headquarter Okara dissects Q.H. Depalpur-I and these three Patwar Circles, mentioned above, are on the right side of the road and the major portion of this Q.H. Depalpur-I is on the left side of the road which is extended to the Depalpur to Pakpattan Road. Therefore, if these

three Patwar Circles are included in PP-185 then their Q.H Shergurh and Q.H. Depalpur-II area will be joining directly to Depalpur to Okara road.

b- That the petitioner is requesting to include five Patwar Circles namely, Ladewal, Jafarabad, 45-S-P, Faridpur Jageer and Additional Faridpur Jageer because Ladewal and Jafarabad (Pundat Munfoolpur) are irrigated through Ladewal Minor which was previously in same union council with the area of PP-186 (that is Sharifabad/Jasoki Dhon etc) and now the union council head quarter Jafarabad is in PP-188 and other part of union council is part of PP-186 so addeding these said Patwar Circles, the local body unit of union council will be in the same constituency. Moreover, Patwar Circles 45-SP, Faridpur Jageer and Additional Faridpur Jageer of Q.H. Haveli Lakha are in union council Bhomanshah of the Q.H. Wandla Jageer. Similarly, a huge Suhag Canal divide this Q.H. Haveli Lakha and this area always remained with the constituency of Wandla Jageer Q.H.

Constituency PP- 187:

- a- That ECP announced delimitation of Constituency PP-187 and the petitioner is requesting to include Patwar Circles namely, Lalewala(Q.H. Depalpur II), Rajowal and Qila Dewan Singh (Q.H. Sheregurh) because Lalewala Patwar Circle is surrounded by the area of Q.H. Hujra-II which is homoganic if it is included in the area of Q.H. Hujra-II and that is PP-187. As far as the Patwar Circle Rajowal and Qila Dewan Singh of Q.H. Shergurh are included in PP-187 it will be homoganic, compact and well linked with main road Kasur to Multan. This PP-187 having area of river belt and Pakistan Indian international border for the convenience of the public. The Constituency PP-187 needs a better communication to this area.
- b- The petitioner is objecting to the extent of Patwar Circles namely, Marrah, Additional Marrah (Q.H. Baseerpur) and Shenwal (Q.H. Hujra-II) because main road Hujra to Haveli is

the main communication source and this area is adjoining to this road and KoekeBahalwal Q.H. area, it is necessary for the sake of homogeneity, compactness and common irrigation system.

Constituency PP-188:

- c- That the petitioner is requesting to include three Patwar Cirles namely, Marah, Additional Marah (Q.H. Baseerpur) and Shenwal (Q.H. Hujra II) in the Constituency of PP-188 which are closed to Koekebahawal Q.H. because it is necessary for the sake of homogeneity, compactness and common irrigation system.
- a- That the petitioner is requesting to exclude five Patwar Circles namely, Ladhewal, Jafarabad, 45-S-P, Faridpur Jageer and Additional Faridpur Jageer because Ladewal and Jafarabad patwar circles have common irrigation system, communication, compactness and local body system.
- 5- That the announced as well as proposed Patwar Circles as below:

- 8- That the petitioner may kindly be allowed to submit additional grounds/reasons for the above said proposals at the time of hearing of this representation.

PRAYER:

In view of the above proposed submissions that it is, therefore, humbly prayed that Jafarabad Patwar Circle may kindly be placed at the right place in map which, is issued by the ECP.

It is further prayed that the representation may kindly be accepted and the provincial constituencies of District Okara be made in accordance of the proposed map of the petitioner for the interest of public convenience, justice and fair play.

Any other relief which this Committee may think fit also be granted.
