ELECTION COMMISSION OF PAKISTAN
THROUGH TENDER NOTICE KHANEWAL

Respectfully Sheweth:-

1. That the petitioners are residents of Revenue Estate Javind Singh Wala and Boota Singh Wala Tehsil Kabirwala District Khanewal and their patwar circle is the same i.e. 5-Kassi Tehsil Kabirwala District Khanewal. The petitioners are the voters of the Constituency PP-206 at present.
2. That the petitioners are aggrieved from the delimitation of the constituencies PP-204 & PP-206 and these both constituencies are required

re-delimitations by exclusion and inclusion of the purposed Patwar Circles herein the grounds. It is important to mention here that the other constituencies i.e. PP-203, 205, 207, 208, 209 and 210 are correct and there delimitations are suitable and convenient of there residents and there is no objection. The re-delimitations of the two constituencies i.e. PP-204 & PP-206 are required on the following reasons

REASONS

- a. That the Qanoogoe Kabirwala-2 Patwar Circle 5-Kassee/Boota Singhwala comprising upon the population of 16209 falls under the constituency of PP-206 Khanewal. This Patwar Circle is adjacent, contiguous and surrounded by the area of constituency of PP-204, which reasonably, fairly and justly is the one unit. The residents, occupants, landowners and voters of the above said

circle of PP-206 used to enjoy all the basic and civic facilities i.e. Roads, Schools, hospitals, malls, water channel, sewerage, canals, bridges, electricity offices of the constituency of PP-204 since long. It is material fact that the aforesaid Patwar Circle of PP-206 is situated at boundary, surroundings and contiguous of PP-204 as shown in the map prepared by the Election Commission of Pakistan, therefore, through the re-delimitation the inclusion of the Patwar Circle 5-Kassi with the constituency of PP-204 will be suitable and convenient to the residents/voters of the aforesaid circles and the same does not cause any inconvenience and effect upon the rights of the residents of PP-206 in any manner whatsoever.

- b. That the Patwar Circle 5-Kassi is attached with the Municipal Committee Kabirwala. The constituency PP-204 based upon the

entire area of the Municipal Committee Kabirwala except the Patwar Circle 5-Kassi which falls within the limits of PP-206, thus the same caused inconvenience to the voters, therefore, it is appropriate and just the same be attached to the constituency PP-204 through the re-delimitation.

- c. That the Qanoogoe Headquarter of Kabeerwala-1, Patwar Circle Kot Bahadar, Koreywala and 13-V falls under the constituency PP-204, District Khanewala. These Patwar Circles are adjacent, contiguous and surrounded by the constituency PP-206, which reasonably is one unit. The residents, occupants, land owners and voters of PP-204 used to enjoy the public facilities i.e. roads, water-channels, kanals, electricity supply and all utility offices of constituency PP-206. It is materially highlighted that the above said Patwar Circles of PP-204 are situated at the

boundary of PP-206, therefore, the inclusion of these 03 Patwar Circles within the limits of PP-206 does not cause any inconvenience and non-suitable effect upon the rights to the residents of PP-204.

- d. That the inclusion of the Patwar Circle 5-Kassi/Boota Singh Wala comprising upon the population of 16209 within the limits of PP-204 by excluding the same from the constituency of PP-206 and inclusion of Patwar Circle of Kot Bahadar, Koreywala and 13-V comprising of population @ 16956 by excluding the same from PP-204 would not make any difference and effect upon the total population of both the constituencies, however, the suggested inclusion and exclusion mentioned above from the respective constituencies provide convenience to the voters of the constituencies to exercise their right of franchise.

e. That according to the population and house hold details the total population of PP-204 was assessed as 373533, whereas it was measured 384384 in the PP-206. The total population of the Patwar Circle 5-Kassi is 16209 and the total population of 03 Patwar Circles i.e. Kot Bahadar, Koreywala and 13-V is 16956, therefore, the inclusion and exclusion of the numbers of persons from the constituency PP-204 & PP-206 will not effect the general voter of the constituency.

f. That the proposed de-limitation shall not cause any effect and infringed the any right of the general voters or the politicians. This proposed de-limitation is only advised in the interest of the general public resident of the said two constituencies.

Under the above mentioned circumstances, it is, therefore, most respectfully prayed that the instant representation may kindly be accepted and the proposed de-limitations may kindly be allowed in the interest of resident of the area and voters.
