OBJECTIONS REGARDING ALTERATION / MODIFICATION UNDER SECTION 21(2) OF THE ELECTION ACT, 2017 AND RULES THERE UNDER REGARDING PP-211 PP-218, PP-219, & PP-220 (MULTAN) ON BEHALF OF MALIK FARUKH NASEEM RAAN SON OF NASEEM HUSSAIN, RESIDENT OF UNION COUNCIL NO. 126, QADIR PUR RAAN SHARQI, MULTAN.

Respectfully Sheweth,

- 1. That the applicant / objector is resident of Union Council 126 Qadir Pur Raan Sharqi, Multan and is registered voter of Riaz Abad, Multan.
- 2. That the applicant raised objection against the alteration and modification of delimitation of the constituencies PP-211, PP-218, PP-219, and PP-220, Multan on the following terms and grounds:-
 - I. That the applicant is resident of Mouza Qadir Pur Raamm, which is now proposed PP-218 against the law on the subject Patwar Circle Sujan Pur has been included in proposed PP-211, as the applicant is voter of above said territory, hence the applicant has constitutional right to challenge the delimitation of above said constituencies off PPs.
- II. That the said proposed constituencies consists on population by Election Commission of Pakistan as under:
 - a. PP-211 373587
 - b. PP-218 362611
 - c. PP-219 361091
 - d. PP-220 347713

- III. That population of the PP-211 is not divided on equal basis and said PP is also not geographically compact. It can be compact and equal by excluding area of Sujan Pur Patwar circle having population 19063 so the population, of PP 211 remains 354524. If the said Patwar circle remains in PP-211 it seems to be odd and tailor cutting.
- IV. That is the population of PP 218 is 362611 and if it is geographically not compact. While after including Sujanpur Putwar Circle having population 19063 and excluding Sher Singh Patwar circle having 12756 population from PP-218 the said PP become compact geographically.
- VI. That is the population of PP-219 is 361091 the area of said PP is not compact. So, my prayer is to include Sher Singh Patwar Circle population 12756 in PP-219 and exclude Patwar circle Jahan Pur having 19065 population from PP-219, in this way the said PP become compact geographically and divides into equal population.
- VII. That is the population of PP-220 is 347713 which is one of the low populated proposed constituency that negates the principle of distribution of equal population which is main feature for delimitation of constituencies So my submission is to include Jahan Pur circle population 19175 in PP-220, in this way population of said PP become 360290 in this way the said PP become geographically compact and its population is also balanced.

PRAYER

It is therefore respectedly prayed that the objection petition may kindly be accepted to constitute the delimitation of PP-211, PP-218, PP-219, and PP-220 by excluding Sujan Pur Patwar Circle from PP 211. And including Sujan Pur Patwar circle to PP-218. And include Sher Singh Patwar circle to PP 219 and include Jahan Pur Patwar Circle to PP-220. Hence, the principles of delimitations which law provided to be complete with respected and implemented in letter and spirit



while delimiting the electoral constituencies, so the not only the candidates but also the voters could be benefited we can number such principles as under.

- i. Distribution of Equal population,
- ii. Geographical Compactness.
- iii. Physical features,
- iv. Existing boundaries of administrative Units,
- v. Facility of Communications,
- vi. Public Convenience, and
- vii. Homogeneity
