ALTERATIONS OR MODIFICATIONS IN THE PRELIMINARY
LIST OF CONSTUTENCY PP215 MULTAN- V

RESPECTFULLY SHEWETH,

1. That the petitioner is a voter of draft Constituency PP215. The name and particulars of the petitioner stands against serial No.212100201 of the voter list published circulated by Election Commission of Pakistan.
(The operative part of the voter list is appended as **annex- A**)
2. The petitioner is aggrieved by the draft / proposed/new delimitation in respect of PP215 Multan -V and seeks proposed delimitation in

PP 215 by making minor amendment or modification in PP 214 and PP216 without inducing major changes in any constituency or other parameters of delimitation as prescribed by this honorable Election Commission.

GROUNDS

1. That the new delimitation as published in preliminary report and preliminary list is against the provisions of Section 20 of the Election Act, 2017 read with rule 10 and 12 of the Election Rules 2017

2. That as per scheme of new draft delimitation PP215 is as follows.
Statistical configuration of PP215 Published or notified by this Honorable Election Commission is given herein below.

The said draft / new delimitation of PP-215 as notified by Election Commission of Pakistan are the composition of the following Charges and circles.

Charge No. 7
Charge No. 8
Charge No. 9
Charge No. 10

The total population assigned to PP215 by Election Commission = 375720

(Photocopy of map PP-215 after delimitation is appended as annex- "B")

3. That the charge 7 has been added and been made part of the constituency which had never been part of the same since the last delimitation done in 2002, even it had never been part of the former Provincial Constituency earlier to last

delimitation. Further it is in violation of the principles that old constituencies must not be disturbed.

4. That the delimitations of both constituencies have not been done as mentioned in rule 10(5) of the Election rules 2017 according to which the delimitation of constituencies of an assembly shall start from the Northern end of the district, or, as the case may be, the agency and then proceed clock-wise in zigzag manner. Keeping in view that population among the constituencies of an Assembly shall remain as close as may be practicable to the quota . Hence the requirement of law has been disregarded during the course of delimitation of the said Constituency PP-215.
5. That it is settled law that census circles should not be divided and broken affecting the basic boundaries of the constituencies, whereas the same has been against the procedure defined by law.
6. That as per delimitation scheme of draft PP-215 the areas of (other constituencies like Former PP- 194, PP-200 and , PP- 202) have been added without any justification and totally ignoring the principle that old constituency should be disturbed at least if it is inevitable.
7. That it is pertinent to mention that during the formation of the said draft constituency PP- 215 , the natural boundaries like railway lines banks of canals and other source of transportation and communication of the constituency and the basic principles and rules of delimitation have been violated and ignored.
8. That the following charges No. 7 have been added wrongly neglecting the natural adjoining Charge 11 in PP- 215.
9. That in order to make the delimitation of PP-215 natural, according to settled principles of delimitation without major changes the following proposal is submitted for the approval of this Honorable Commission.


