REPRESENTATION UNDER SECTION 21, 22 OF THE  
ELECTION ACT 2017 READ WITH RULE 12 OF THE ELECTION  
RULES 2017 AGAINST THE PROPOSED DELIMITATION OF  
PROVINCIAL ASSEMBLY CONSTITUENCY PP-245  
BAHAWALPUR-I DISTRICT BAHAWALPUR FOR THE  
REASONS BELOW.

Respectfully Sheweth:

1. That the petitioner is a registered voter of the proposed constituency of PP 245 Bahawalpur-I of District Bahawalpur. The attested extract of voter list showing petitioner as voter is attached as Annexure "A".
2. That the proposed constituency of PP-245 Bahawalpur-I consist of 3,76,625 voters. The adjacent constituency of PP-246 Bahawalpur-II District Bahawalpur consist of 385486 votes.
3. That while delimiting constituencies of Provincial Assembly in District Bahawalpur following changes have been made:-
  - a. The area of U.C No.20 & 21 constituting of 35,235 have been detached from PP-252 Bahawalpur-viii and has been added upon in PP-246-Bahawalpur-II.
  - b. The previous delimitation of PP-245 Bahawalpur-I & PP-246 Bahawalpur II has been changed / reshuffled for no good reason. This change / addition is impracticable, against geographic compactness, physical features, existing boundaries of administrative units, facilitates of communication, public convenience and wrong distribution of population.

PROPOSAL.

That the PP-245 Bahawalpur-I and PP-246 Bahawalpur-II and PP-252 Bahawalpur viii may kindly be reconstituted in the following manner.

- S/31/03/2019*
- a. Area of U.C No. 20 and 21 (Fatoowali and Rama) be subtracted / deleted from PP-246 Bahawalpur-II and be again added to PP-252 Bahawalpur viii as has been the practice from last many decades.
  - b. The previous delimitation / constituency of PP-245 Bahawalpur-I and PP-246 Bahawalpur-II may kindly be restored.

PRAYER

It is therefore humbly prayed that constituencies PP-245 and PP-246 may kindly be reconstituted by substraching areas of U.C Nos. 20 and 21 (Fatoowali and Rama) from PP-246 Bahawalpur-II and the same may be added upto constituency PP-252 Bahawalpur-viii.

ii. The previous delimitation of PP-245 Bahawalpur-I and PP-246 Bahawalpur-II may kindly be restored.
