

It is basic principle of delimitation that all the seats shall, as far as practicable delimited having regard to the distribution of population in Geographically compact areas, physical feature, existing boundaries of administrative unit, facilities of communication and public convenience and other cogent factor to ensure homogeneity in the creation of constituencies.


