RAHIMYARKHAN-I, 256 RAHIMYARKHAN-II & 257  
RAHIMYARKHAN-III ISSUED BY THE RESPONDENT.**

### GROUNDS

A. That the delimitation authority overlooked the Principles of delimitation ---(1) All constituencies for general seats shall, as far as practicable, be delimited having regard to the distribution of

population in geographically compact areas, physical features, existing boundaries of administrative units, facilities of communication and public convenience and other cognate factors to ensure homogeneity in the creation of constituencies.

B. That Delimitation Authority without any legal justification, has distributed the QH Tarukari in two constituencies i.e. PP-255 & PP-257 without any legal justification and without any plausible reason, whereas, the QH Tarukari is the 1<sup>st</sup> QH/starting point of District Rahimyarkhan and the population of the said QH Tarukari and in PP-255 PCs of QH Khan Bela have been included without any plausible reason and without any legal justification and due to this act of delimitation authority, the QHs of Tehsil Liaquatpur have been disturbed and its PCs have been included in different Constituencies.
