1. That the petitioner belongs to District Rahim Yar Khan having Vote at serial No.523, Census Block Code 2510902014, Electoral Area Qadir Pur, Khanpur, District Rahim Yar Khan. The respondent has made preliminary list of delimitation of constituencies for District Rahim Yar Khan as PP-255 Rahim Yar Khan-I, PP-256 Rahim Yar Khan-II, PP-257 Rahim Yar Khan-III, PP-258 Rahim Yar Khan-VI and PP-259 Rahim Yar Khan-V for the Provincial Assembly Punjab.
2. That the Delimitation Committee Punjab has made following preliminary list of delimitation of constituencies for District Rahim Yar Khan Provincial Assembly of Punjab.

3. That being aggrieved and dissatisfied with the above said preliminary list of delimitation of constituencies dated 05.03.2018, the petitioner preferred representation, legal objections, inter-alia, on the following grounds: -

**GROUND**

a. That the petitioner is registered voter of Qadir Pur Tehsil Khan Pur District Rahim Yar Khan as such entitled to make representation to raise objections for alteration and

- b. That the petitioner has been contested the local council elections of Union Council Qadir Pur, Tehsil Khan Pur District Rahim Yar Khan and succeeded to elected as Chairman of Union Council Qadir Pur District Rahim Yar Khan, Punjab.
- c. That preliminary proposal of delimitation for provincial assembly seats in District Rahim Yar Khan has been issued while violating the geographic compactness of the areas, physical features, existing boundaries of administrative units, facilities of communication, public convenience and other cognate factors to ensure homogeneity in the creation of constituencies in District Rahim Yar Khan as enumerated in Section 20 of the Elections Act 2017 and Rules 7,8,9 and 10 of the Elections Rules 2017.
- d. That the delimitation committee has proposed the preliminary list of the constituencies for Provincial Assembly of Punjab in District Rahim Yar Khan keeping aside the guidelines given in the Act and

e. That in the preliminary list of constituencies there has been gross violation of sub section 1 of section 20 of the Election Act 2017 by not considering the existing boundaries of administrative unit intact, which requires to keep the existing boundaries of administration unit in tact as far as practicable. The boundaries of administrative units have not been divided conveniently without applying the principles as laid down in the Act 2017 and Rules. While creating preliminary list of delimitation of constituencies, the delimitation committee had disturbed the Halqa Qanoon Goi of Samoka and Patwar Circles viz Kotli Murad PC, Lanjwar PC, and Pai Ahna PC which would result into grave hardships for the public at large to approach the central part of their respective areas, health units/hospitals, Courts, communications and interaction with themselves and others and also to approach their representative.

f. That if the preliminary list of constituencies of the above said District are not set-aside modified and

amended the public at locality as well as at large would suffer an irreparable loss.

g. That according to preliminary list of provincial constituencies the actual facts at grounds are not considered the District has been divided in a zigzag manner instead of smooth pattern. Without centralizing each constituency, far-flung areas have been included, instead of adjacent areas. Moreover, disturbance has been created to approach the National Highway and other communications to the local people as the people would have to travel through different areas of Tehsils to enter into different parts of same constituency. The inclusion of Kotli Murad PC, Lanjiwar PC, Pai Ahna PC in PP-256 Rahim Yar Khan-II would be suitable on account of business, social communication, to access main part of the areas and to get common facilities. In addition the approach of students to school and colleges of same constituencies would also be disturbed. Furthermore, these three Patwar Circles are required to be added in PP-256 Rahim Yar Khan-II as they have same Halqa Oanoon Goi of Samakha

- h. That the petitioner is submitting proposals after serving the ground realities and taken into consideration all the relevant factors as envisaged under Section 20 of the Election Act, 2017 and rules.
- i. That the marked map of the provincial constituencies of District Rahim Yar Khan are attached.
- j. That other grounds would be addressed with the permission of this Honourable Commission at the time of arguments.
