Subject: **LEGAL OBJECTIONS AND PROPOSALS OVER THE PRELIMINARY LIST OF NATIONAL ASSEMBLY CONSTITUENCIES OF DISTRICT MUZAFFARGARH.**

Respected Sir,

The undersigned applicant submits as under:

1. With reference to notification No. F. 8 (3)/2018-Elec-1 dated 5<sup>th</sup> March, 2018 whereby, honourable Commission will hear and decide the objections/representations under sub-section (4) of Section 21 of the Elections Act, 2017 in connection with preliminary list of National and Provincial Assembly constituencies of Pakistan.

2. That the criteria for delimitation of National and Provincial Assembly constituencies is laid down in sub-section (1) of Section 20 of the Elections Act, 2017 is as under

“ all constituencies for general seats shall, as far as practicable, delimited having regard to the distribution of population in geographically compact areas, physical features, existing boundaries of administrative units, facilities of communication and public convenience and other cognate factors to ensure homogeneity in the creation of constituencies”

3. Although, while delimiting the constituencies of National and Provincial Assembly of district Muzaffargarh, to large extent, the principles of delimitation have been kept in view by the Election Commission of Pakistan. But the possibility of human error cannot be ruled out. In case of Provincial Assembly Constituencies PP-277 and PP-278 of Muzaffargarh District, the criteria, meant for delimitation, has been overlooked.

4. In view of above discussion, I hereby submit my **LEGAL OBJECTIONS AND PROPOSALS**, with regard to PP-277 and PP-278 of Muzaffargarh District.

#### **LEGAL OBJECTIONS**

- e) The applicant is voter of proposed constituency of Provincial Assembly PP-277.
- f) Patwar Circles Widad and Basti Arif of Jhalarin Q.H. of Tehsil Jatoi have been made a part of Provincial Assembly Constituency PP-277. But the map of District Muzaffargarh shows that Patwar Circles, Shahbazpur and Jangal, included in proposed constituency PP-278, are located in between and separates Patwar Circle Widad/Basti Arif from the rest of the area included in PP-277. It is against the principle of delimitation that the constituency shall consist of geographically compact area.
- g) Secondly, the map also shows that direct communication facilities are not available to the people of under discussion Patwar circles Widad and Basti Arif to remain in contact with the people, living in the major area of proposed constituency PP-277.
- h) While creating preliminary list of constituencies PP-277 and PP-278, the geographically compact area and public convenience has not been considered.

- iii. My proposals do not affect any other constituency of National Assembly/Provincial Assembly of District Muzaffargarh except NA-185 and NA-186, PP-277 and PP-278.
- iv. The applicant has no objection with regard to delimitations of other National and Provincial Assembly constituencies of District Muzaffargarh.

**SUGGESTIONS**

- iii. In the light of above submission, minor amendment is suggested to reconsider the delimitation of NA-185 and NA-186, PP-277 and PP-278. The suggestion is in accordance with the principles of delimitation, laid down by the Election Commission of Pakistan.
- iv. It is suggested that Patwar Circles Widad and Basti Arif of Jhalarin Q.H. of Jatoi Tehsil, having 24555 population is required to be excluded from Provincial Assembly Constituency PP-277 and suggested to be included in PP-278.

In the same manner, minor amendment is suggested for NA-185 and NA-186. Only two Patwar circles, Widad and Basti Arif of Jhalarin Q.H. of Tehsil Jatoi, having 24,555 population, are required to be excluded from NA-186 of Muzaffargarh-x and suggested to be included in NA-185 of Muzaffargarh-xi.


