REPRESENTATION/OBJECTION PETITION UNDER SECTION 21(2) OF  
THE ELECTION ACT, 2017, READ WITH RULE 12 OF THE ELECTION  
RULES, 2017, AGAINST GERRYMANDERING IN THE DELIMITATION OF  
CONSTITUENCIES OF PROVINCIAL ASSEMBLY OF THE PUNJAB OF  
DISTRICT RAJANPUR.

Respectfully Sheweth;-

1. That I, Shaukat Mehmood S/O Malik Mehmood Bakhsh Anjam NIC # 32403-5972997-3, R/O Sikhani wala, P/O Tehsil & District Rajan Pur is bona-fide resident and registered voter of Constituency No. PP-295 Rajan Pur-III, of district Rajanpur, delimited and published in the Preliminary List of Constituencies.
2. That the Election Commission of Pakistan has published Preliminary List of Provincial Assembly Constituencies of district Rajanpur along-with other districts of the Punjab, vide ECP's Notification No. F.8(3)2018-Elec-1, dated the 5<sup>th</sup> March, 2018. (Annexure-A).
3. That Rajan pur district administratively comprising 3 Tehsils, i-e, Jampur, Rajanpur, Rojhan and Tribal Area called de-excluded area with Total Population of 1,995,958, in terms of Provisional Results of Census-2017, released by the Census Organisation, and 05 constituencies of Provincial Assembly of the Punjab has been allocated.
4. That Quota for each Provincial Assembly Constituency of Rajan Pur district comes to 399,192 with Maximum upper limit of Population of 419,151 and Maximum Lower limit of Population of 379,232 and

maximum permissible variation of Population between two or more constituencies of Bahwalpur district is 39,919. (Summary district Rajan Pur is at **Annexure-B**)

5. That the delimitation of district Rajan Pur is defective as one patwar circle **Pahar Pur** is of Part of Rajan pur Colony but lies in the middle of QH Kotla Issan, hence not contiguous to the rest of the area of its Constituency.

6. That the marked Map of District Rajan Pur pertaining to Provincial Assembly Constituencies, provided on cost from the office of the Provincial Election Commissioner, Punjab is illegible, unreadable and nothing more than piece of paper. However a better copy of the same is at

7. That one **Pahar Pur Patwar Circle of Rajan Pur Colony QH** has been included in PP-296 alongwith other PCs of the QH But this very PC is lying in the middle Kotla Esan QH which is part of PP-295 which illegal and unsustainable.

That keeping in view the principles as enshrined under the Election Act, 2017 read with Rule 10 of the Election Rules, 2017, a plausible proposal/suggestion has been prepared for the consideration of this August Commission and the counter proposal has strictly been framed in compliance of principles of delimitation in their entirety, totality and spirit. (**Proposal is at Annexure-D**)

It is, therefore, very humbly requested that the Patwar Circle Pahar Pur may be detached from Constituency No. PP 296 and be attached with PP-295 to make the contituncies contiguous and compact to ensure free, fair and just election in accordance with the constitution and the law and to give level playing fields to all
