Subject: Proposal Under Section 21(3) election act 2017 read with rule 12 of election rule 2017 regarding alteration of modification in the Constituency PP 37 previous PP 129.

Dear Sir,

Reference to Election Commission of Pakistan notification F8 (3)/2018 dated 5 March 2018,

The under signed is a registered voter of electoral block No180030905, village Challakayof NA-73 and PP-37 of Tehsil, Daska, Sialkot district, thus is entitled to file a proposal for alteration in the extent of the constituencies of Sialkot district because the same as notified by the Commission is not based on geographic realities of the district. It also contains many errors and omission and needs improvementas per detail given below:

- The population of Sialkot district according to Population 2017 is 3,893,672/- and
 there is no change in number of National and Provincial assemblies
 constituencies which remains 5 and 11 respectively. Therefore, no major change
 was required to re-delimit all the constituencies afresh except for minor changes
 in the extent of existing boundaries of constituencies to balance the distribution of
 population.
- Area of former PP 129 has been divided into 3 newly created constituencies' i.e. PP-37, PP-38 & PP-39 without having regard to the principles of delimitation laid down in the subject cited ACT and because of that most of the population is badly affected.
- Marking of maps showing the areas assigned to the constituency does not match
 with the description given in the text like as Matakay Nagra &Rachara PCs of
 Buda goraya QHs are part of PP-37 while in Map are part of PP-39.Adamkay
 Nagra PCs of Pasrur 1 QHs in list of constituencies is part of PP-36 while in
 MAP part of 39, etc so should have to make amendment to match these.
- PP- 37 is not compact and contiguous at all and the map marked by the Commission shows the reality highlighting the area falling PP-39 make the

position clear and is over lapped by the other constituencies with an estimated gap of 15km in between PP-36, PP-38 & PP-39 Areas like Matakay Nagra, Rachara etc. PCs of Buda goraya QHs of PP-37 are far away from the remaining area.

- PP- 37 is very lengthy and it touches borders of 3 districts i.e. Narowal, Gujranwala, Sheikupura and estimated distance within PP-37 is estimated more than 70km and same problems is also with other constituencies of Sialkot but by my proposal It will reduce significantly.
- Some QHs areasare not tagged together for example Rachara & Panjgrian Pcs
 of Buda GorayaQHs and Adamkay of Pasrur 1 QHs are far away from rest of the
 QHs area so these factors require consideration.
- There is no proper road link within the new designed constituencies and have to travel long from others constituencies which overlap the same to visit within the .PP-37.
- The constituencies of Sialkot district have been drafted in violation of Rule 5 of Delimitation Rule 2017 which reads as under
- " (5) As far as possible, the delimitation of constituencies of an Assembly shallstart the Northern end of the district, or, as the case may be, the agency and then proceed clock-wise in zigzag manner keeping in view that population among the constituencies of an Assembly shall remain as close as may be practicable to the quota:"

While these have been started from south of the district instead of North, population are not close and all area is not contiguous.

So the undersigned requests the Honorable Commission to consider the above facts and order the changes for adjustments as the area of PP-36 & 38 which is in between 37 should attached with it and areas of PP-37 which is near to these constituencies should attached with them. The our proposal for these 3 constituencies which will cover these factors and will not affect other constituencies is as follow.
