

# BEFORE ELECTION COMMISSION OF PAKISTAN

## REPRESENTATION OBJECTION PETITION U/S 21 OF ELECTION ACT 2017 AND RULE 12 OF THE ELECTION RULES 2017 RELATING TO PP-42- AND PP-43

It is most respectfully submitted

1. That the petitioner is voter of PP-42 Sialkot VIII. Hence he is entitled to present this instant petition.

a) Copy of the ID Card extract from the electoral Roll is attached herewith.

b) That PP-42 Sialkot VIII comprise of the following QHs of Sialkot Tehsil:

i) Gunna Kalan

ii) Sialkot-1  
of Sialkot District.

And it's total population is 3,69,101/-.

2. That the patwar circles of Gunnah Kalan of PP-42, unfortunately does not consist of those patwar circles which are contiguous to each other out of 21 patwar circles Two patwar circles Bhoth-I & Bhoth-II are not adjacent to remaining patwar circles. Due to this reason the principle of contiguous of area and compactness of block has been broken which is essential principle of delimitation the area which is not contiguous with each other cannot fall within part of constituency.

3. That the population of Bhoth-I & Bhoth-II is as under;

Bhoth-I	50,678/-
Bhoth-II	10,486/-
Total	61,164/-

Which are adjacent to PP-43- and it's a geographically natural and ineventable/integral part PP-43 it cannot be included any other constituency, and map of district Sialkot issued by election commission of Pakistan which is showing the difference among PP-35 to PP-45 it self reveals that Bhoth-I patwar circle and Bhoth-II patwar circle are in PP-43 instead of PP-42. This is against the preliminary lis of delimitation issued by Election Commission. In order to make contiguity of constituencies this has been shown in the area where it's actual fall.

4. That the disparity of population which comes due to inclusion of these two patwar circles in PP-43 then the remaining and adjacent population and patwar circles of PP-43 can be added with PP-42 and those patwar circles are as following;

- a). Kundan Pur (PC) = 7,892/-
- b). Dalowali-I (PC) = 14,174/-
- c). Dalowali-II (PC) = 8,222/-
- d). Jhulki-I = 9,748/-
- e). Jhulki-II = 18,204/-
- Total = 58,180/-

5. That if patwar circles Bhoth-I & Bhoth-II be excluded from PP-42 and patwar circles Kundan Pur, Dalowali-I, Dalowali-II, Jhulki-I and Jhulki-II be included it's population will be as under;

6. This is Pertinent to mention here that both PP constituencies above mentioned comes under the same national assembly constituency NA-76, it is therefore any change in both constituencies does not effect national assembly constituency.

7. That if the above mentioned suggestion are accepted than the violation of contiguity of area shall be ranctified and both the population will remain within the permissible limit of relaxation
