Subject: Delimitation of Constituency –Provincial Assembly of Punjab- PP 5

Respectfully Submitted,

Attention is invited to ECP notification dated 5 March 2018 on the above subject and the Pakistan Election Act 2017.

2. The petitioner feeling aggrieved to the proposed delimitation submits the following:-

The notified constituency PP 5 (Attock V) consists of;

- Tehsil Jand
- QH Surag of Pindigheb Tehsil
- The patwar circles of QH -I Attock
 - a) Surg Salaar
 - b) Choi Ghariala
- The patwar circle of QH –II Attock
 - a) Boota
 - b) Akhori

The above delimitation is contrary to Section 20 of Pakistan Election Act 2017 and ECP notification F-8(3/2018-Elec-I) dated 05-03-2018 as submitted below:

- I. As per Rule 10(5) of Election Rules 2017, the constituency was required to be delimited from North to South in a clockwise direction. If this principle was adhered to, the excess population of Provincial Assembly PP-1 (Attock I) would have been added to PP-2 (Attock II) and not PP-5 (Attock V).
- II. Section 20 (5) of the Pakistan Election Act 2017, also, specifies that constituencies should be compact and contiguous, while in the subject proposal, areas from three tehsils have been joined to form one provincial assemble constituency.
- III. Section 20(1) also states that physical features need to be kept in view so as to make the constituency geographically compact. There is a marked deviation from this requirement as the 3 patwar circles of Attock Tehsil are on opposite sides of the massive Kala Chitta range of mountains. This mountain range has also been declared a restricted area with limited access to the civilian population which would in effect deprive the voters of these 3 patwar circles access to their compatriots in Tehsil Jand and vice versa.
- IV. In all electoral exercises since the advent of 1973 constitution, this geographical barrier has never been crossed in any election to the Provincial Assembly.
- V. Sub-Section 1 of Section 20 also stresses on provision of lines of communication to all voters. In the present case patwar circle Boota

(QH- II/ Attock) while only 10 km from Attock city is over 100 km away from Jand city/ tehsil headquarters, the main town of PP-5 (Attock V) and similar distances separate PC Surg Salaar and PC Choi Ghariala (QH-I/Attock) from Jand.
