- (a) Patwar Circle Adil Garh, Darweshke, Kot Noora and P.C Wayianwali have been detached from the remaining part of Q.H Ghakkar and included in this constituency. All these Patwar circles should have been delimited together along with other part of Q.H. Ghakkar in PP 51 Gujranwala-1.
- (b) That charge No. 12 of Municipal Corporation Gujranwala except Circle No. 8 is part of Q.H. Talwandi Rahwalai, therefore, it should have been included in this Constituency.
- (c) That charge No. 12 is contiguous to Q.H.- Talwandi Rahwali and should have been included with the other part of Halq Q.H. Talwandi Rahwali which has been included in this Constituency.
- (d) That in order to equalize the populations village Patwar Circle Abdal, (Village Ghghaywali) should be excluded from PP-53 and included in PP 59 Gujranwala-IX
