**REPRESENTATION AGAINST DRAFT DELIMITATION PROPOSALS IN RESPECT
OF PP-56 AND PP-57 CONSTITUENCIES OF DISTRICT GUJRANWALA.**

It is respectfully stated as under:

1. That the Petitioner is resident and voter of PP-57 constituency, District Gujranwala and wish to draw attention towards serious violations of principles of delimitation as laid down in The Elections Act 2017.
2. That the principles of delimitations were not taken into consideration at the time of delimitation of PP-56 and PP-57 Constituencies which are detailed as under:

i) That the PP-56 consists of:

- iii) That the principle of geographical compactness, homogeneity and contiguity was violated in delimiting PP-56 and PP-57 Constituencies. Map of both constituencies is attached as Annex-1 & I-A.
- iv) That areas contiguous to PP-56 were included in PP-57 whereas areas contiguous to PP-57 were included in PP-56.
- v) That the principle of facilities of communication and public convenience was also ignored.
- vi) That existing PP-56 is not contiguous with PP-55 constituency which is violation of rule of clockwise delimitation as laid down in The Election Rules, 2017.

3. That the under mentioned changes are proposed in the draft delimitations which will make both PP-56 and PP-57 constituencies in line with the principles of delimitations:

- i) That Charge No.37 and Charge No.38 be excluded from PP-56 and included in PP-57 constituency and Charge Nos. 24, 25, 26, 28, 30 and 31 be excluded from PP-57 and included in PP-56 constituency in lieu thereof. Annex.2, proposed map.
- ii) That after incorporation of above said proposals in para 3 (i) above, the composition of PP-56 constituency will be as under:

iv) That the marking of rest of the District remains the same and there will be no change/effect on other constituencies after making correction in the proposed delimitation.

It is, therefore prayed that the proposals of changes in PP-56 and PP-57 constituencies, District Gujranwala as stated in para 3(i),(ii) & (iii) above may very kindly be accepted as these will fulfill the criteria of principles of delimitation as laid down in The Elections Act 2017 and The Election Rules 2017.
