**Dear Sir.**

Vide Notification No.F8(3)2018-ELC-1, in pursuant to Section 21 of the Election Act, 2017 read with Rule 11 of the Election Rules, 2017, the Election Commission of Pakistan has published for information to general public preliminary report and list of constituencies in respect of the Punjab Provincial Assembly.

2. According to FORM-5 (Draft List of Constituencies) PP-94 Chiniot-II, consists of the areas, the detail of which showing population is as under:-

3. Thatha Fateh Ali (PC) is a part of Bhowana QH and the whole Bhowana QH has been included in PP-95. It is pertinent to mention here that in the map issued by the Election Commission, Thatha Fateh Ali (PC) has not been shown in PP-95. It is a technical / clerical mistake and it may be rectified. In total population of PP-95, the population of Thatha Fateh Ali has been calculated.

4. I am a resident of Chak No.197/JB (PC Chak No.204/JB) and a voter of the locally. Patwar circle Chak No.204/JB has been included in PP-94. It is unnatural amalgamation with PP-95. It will be convenient and feasible for the residents of Thatha Fateh Ali to remain in PP-94. The patwar circle Thatha Fateh Ali is a part of constituency PP-94 since along and the population of this area has been dealing with

the other residents of the constituency in respect to all the worldly affairs. If the patwar circle Thatha Fateh Ali is included in PP-94 and the patwar circle Chak No.204/JB is excluded from PP-94 and is included in PP-95, the population of the constituencies will not increase from the prescribed limit. Moreover, to equalize the population more appropriate, the patwar circle Chak No.221/JB also may be included in PP-94. If so, the population of both the constituencies will be as under.

(I) PP-94 ----- 342786

(II) PP-95 ----- 340167

5. If the purposed change in PP-94 and PP-95 is accepted, both the constituencies will become compact areas and will be more convenient for the people of the respective patwar circles and the administrative units (union councils) will not disturb.
