Subject: **REPRESENTATION UNDER RULES 12, OF THE ELECTION RULES, 2017, (THE RULES READ WITH SECTION 20 OF THE ELECTON ACT, 2017 CHALLENGING THE PRELIMINARY PROPOSAL OF P-77 & 78 (SARGODHA-VI & VII RESPECTIVELY)**

Respected sir,

1. The Instant representation is being filed by Major (R) Shahbaz Ahmed Bajwa, Advocate No.42 of PP-78 (Sargodha-VII). The applicant is duly competent to file the instant representation under the law .
2. That through this representation the applicant seeks to change delimitation proposal published by the Election commission of Pakistan (hereinafter referred ECP) pertaining to the delimitation of PP-77 Constituency Sargodha-VI and PP-78 constituency Sargodha-VII hereinafter referred as preliminary proposal which was provided by the Election commission of Pakistan.
3. That map of Preliminary proposal provided by ECP is also attached as Annexure "B".
4. That the proposed Map of delimitation for PP-77 and PP-78 is also attached with application for reference and attached As Annex "C".

5. **OBJECTION:**

- a. That charge 1 and PC Derehma was previously part of PP-35 . According to new plan of ECP one PP constituency of Sargodha i.e. PP-35 is removed and due to that effect area of PP-35 is distributed in other neighboring PP constituencies.
- b. That during this process ECP has included Sargodha 1 and Derehma PC to my constituency i.e PP-78 (old PP-34).
- c. That while including Sargodha 1 and PC Derehma ECP has not considered the main factor/consideration that said included areas have no physical and geographical link with my constituency i.e PP-78.
- d. It is very pertinent to disclose that said area (PC Derehma and Sargod-I are physically and geographically attached with PP-77 (Old PP-33).
- e. I am in the opinion that ECP due to mistake or negligence and knowing fully well that said area (Sargodha-I and PC Derehma) has not physical, geographical and communication link with my constituency i.e. PP-78.
- f. That after including the said area to my constituency ECP has excluded charge 14 from my constituency i.e PP-78 to PP-77 for the purpose to make the population balance.
- g. Sir, I am unable to understand that why ECP has given charge 14 to PP-77 (Old PP-33) knowing fully well that charge 14 historically,

physically and geographically is attached with my constituency PP-78 and the most serious mistake by ECP that including PC Deherma and Sargodha-I in my constituency PP-78 which has no geographical link with my constituency.

6. Keeping in view, law in my mind and legal considerations I proposed following changes/alterations in your preliminary proposal issued by ECP:-

- a. That Deherma and Sargodha-I shall be remain part of PP-78 (Old PP-34) as planned by ECP.
- b. That charge 10 area shall be included in PP-78 (Old PP-34) due to this effect and alteration PC Deherma and Sargodha-I will become physical physically and geographically compact with each other, Moreover due to this effect of PP-78 will become compact geographical unit.
- c. That after this change/alteration for the purpose to complete the population balance charge-17 from PP-78 shall be included in PP-77. It is necessary to bring this fact notice that charge 17 is physically attached with charge 14.
- d. That according to my suggestions there will be only two minor changes those are charge 17 shall be included in PP-77 and charge 10 shall be included in PP-78. Due to these two changes both the constituencies will geographically compact.
