THE ELECTION RULES 2017 (THE RULES) READ WITH SECTION 20 OF THE ELECTION ACT-2017 CHALLENGING THE PRELIMINARY PROPOSAL PERTAINING TO THE DELIMITATION OF PROVINCIAL ASSEMBLY SARGODHA-VII, PP-78

Respected Sir,

- 1. The instant representation is being filed by Muhammad Asif Iqbal hereinafter referred to as Applicant Voter No. 424 of PP-78 Sargodha VII. The applicant is duly competent to file the instant representation under the Law.
- 2. Through this representation the applicant seeks to challenge preliminary delimitation proposal published by the Election Commission of Pakistan (Hereinafter referred ECP), pertaining to the delimitation of PP-78 Sargodha VII. I Hereinafter referred as preliminary proposal which was provided by the Election Commission of Pakistan, as attached Annexure-A.
- 3. That previous constituency is disturbed without any justification without any law, due to which charge

No. 14 is shifted from my previous constituency PP-34, new PP-78 to PP-77.

This is against the act. That historically and geographically charge No. 14 compact with PP-78.

- 4. That previously the most prominent land mark that is RAILWAY LINE separate both the constituencies these are PP-77 and PP-78
- 5. That Sargodha-Bhalwal road is also a land mark which separates both the constituencies.
- 6. That PP-78 consists of people who have the same social values and common graveyards etc.
- 7. That my constituency previously consists of 10 Cantt Areas words administrative and 6x MC's, but due to preliminary proposal of <u>EC</u>,the pattern of MC's have also been disturbed.

The pattern of 3 MC's of PP-78 has been disturbed as follow:

- 1. MC-3 1 word of this MC has been attached with PP-77.
- 2. MC-4 from this MC 4 words has been separated.
- 3. MC-5 3 words of the said MC has been detached from PP-78 and allotted PP-77.

All the above MC's area has their MC Chairman's in PP-78 and in provincial constituency they will be under PP-77 which will create many problems to the people living there.

8. That taking out charge 14 has drastically changed my constituency and allotting extra area for the purpose to complete population balance is not geographically compact with my constituency.

- 9. Keeping in view above mentioned facts following area the objection are delimitation of PP-78 (Sargodha VII)
- (a) That QH-I PC Dhrema has no geographical compactness with my constituency PP-78, whereas the same area is geographically adjusting with PP-77, and there is no direct communication link with PP-78 moreover to approach new allotted area. One has to cross whole of the PP-77. This is against the principle of delimitation.
- (b) That there is no justification to detach the charge -14 from PP-78 and giving to PP-77.
