The instant representation pertains to proposed PP-08;

The Municipal Committee (MC) Gujar Khan of PP-08 having population of 90131 has been created an Island within the area of PP-09 which is delinked form PP-08; Therefore to remove the anomaly and address the public inconvenience the two Patwar Circles namely PC-Dhuman and PC-Gujar Khan of PP-09 collectively having population of 19057; which are sandwich between the subject MC-Gujar Khan of PP-08 and rest of the boundary of PP-08, be included in PP-08; The Applicant/Petitioner is registered voter of the subject proposed constituency PP-08; challenges the same on the following grounds:

### GROUNDS

- a. That the preliminary delimitation of constituency has been published through public notice by the Election Commission of Pakistan; Which is in gross violation of laws, rules, procedures, principles and provisions as well as sections laid down in Election Act 2017; The same is liable to be rectified to the extent of prayer of the petition to meet the ends of

justice and to be in accordance with the rules, provisions, laws, section and true spirit of Election Act 2017;

- b. The Quota Per Seat for the constituency of Provincial Assembly from the Province Punjab is 370,429;
- c. The total population of proposed constituency PP-08 is 350,413; which includes the population of subject MC-Gujar Khan; The MC-Gujar Khan of PP-08 has been created an island within the constituency PP-09;
- d. The MC-Gujar Khan being hub of social and economic interest of the inhabitants of PP-08 merits to be connected/included with rest of the PP-08; Therefore to remove the anomaly the two the Patwar Circles namely **PC-Dhuman and PC-Gujar Khan** of PP-09 collectively having population of 19057; which are sandwich between the subject MC-Gujar Khan of PP-09 and rest of the area of PP-08; merits to be included in PP-08 in the best interest of the inhabitants of PP-08;
- e. The suggested inclusion of the two Patwar Circles namely PC-Dhuman and PC-Gujar Khan shall not affect the population Quota of PP-08; Explanation given under;

f. That according to Election Act 2017 and Rules framed thereunder; the two Patar Circles PC-Dhuman and PC-Gujar Khan merits to be included in PP-08 and excluded from PP-09 on the basis of compactness, homogeneity and typography in the interest of the inhabitants;

**PRAYER:**

In the light of the above mentioned it is therefore prayed:

- a. The two Patwar Circles namely PC-Dhuman and PC-Gujar Khan of PP-09 shall be added in PP-08;
- b. Any other relief to which the petitioners are entitled may kindly be granted in the interest of justice.
