

PETITION OF OBJECTIONS

Respected Sir,

The petitioners, above-named, most respectfully and very humbly, submit as under:-


- 1. That the petitioner are the resident and voter of PS-105 & PS-106 and have gone through the fresh Delimitation of the Constituencies as announced by the Election Commission which according to Election Commission is described in annexed schedule.
- 2. That the Delimitation as marked by the Election Commission is not in accordance with the policy of Election Commission in respect of Geographical Compactness of a Constituency. Whatever Delimitation made by the Election Commission in respect of PS-105 and PS-106 is not correct in respect of Geographical Boundaries. The above referred delimitation is not correct in respect of geographical nature as one part of PS-106

and public of the area have reservations/ objections to such inclusion in PS-106 as the area of Mehmoodabad is at a distant place from Society and Lines Area and for the said purpose public has to cross the big road of Shahrahe-Faisal and the said area was also situated behind the Railway Line, therefore, for the purpose of public utilities, hospitals, Police, UCs, Birth, Death, Nikah, Talaq and residential certificates alongwith educational institutes all were situated in Sub-Division Ferozabad, therefore, the public has to face lot of problems.

- 3. That the Election Commission has announced that the Delimitation is carried out in order to provide facilities to the voters for big turnout but the above Delimitation reflects otherwise, as due to such distances, vote casting would be reduced. Therefore, charge 15 of PS-106 shall be included in PS-105.
- 4. That in order to create a balance in the population of Ferozabad Sub Division, its charge # 13, Code # 44013 having a population of 12046 and charge # 4, Code #



By doing such inclusion and exclusion population from one PS to other PS, Election Commission will create ease and tense free demarcation in order to achieve the aim of increase in vote casting ratio, otherwise, public has to cross 600 feet big Shahrah-e-Faisal for casting votes. It is pertinent to mention here that the maximum limit of speed is 80 kph and the said witnessed VIP Shahrah-e-Faisal is also frequently, therefore, public has to face disturbances if the above proposals have not been changed or accepted. Proposals are annexed as schedule.

5. Election demarcation as by the made Commission of PS-106 and 105 is based on vertical distribution which resulted into differences in populations and creating ethnic differences which is also against the decision of Hon'ble Supreme Court of Pakistan reported in PLD 2011 Supreme Court 997 that the demarcation shall not be for the benefit of any political party but based on smooth population and multi-linguistic areas. The relevant portion of the judgment is reproduced

"Further observe that to avoid political polarization and to break the style of ethnic strife and turn war. boundaries administrative units like police stations, revenue estates, etc., ought to be altered so that the members of different communities may live together in peace and harmony, instead of allowing various groups to claim that particular areas belong to them and declaring certain areas as NO GO areas under their fearful influence. Subsequent thereto, on similar considerations, in view of relevant laws, delimitation of different constituencies has also to be undertaken with the same object and purpose, particularly to make Karachi, which is the hub of economic and commercial activities and also the face of Pakistan, a peaceful city in the near future. The Election Commission of Pakistan may also initiate the process of its own in this behalf."

6. That the majority of Urdu Speaking population is residing with the people of other languages but the proposed setup creating ethnic distribution.

So in order to create harmony among the different languages and maintaining geographical setup,
