Subject: Memorandum of representation against the delimitation of constituencies of district West Karachi regarding PS 119 & PS 120

Respected Sir

We, Siddique Akber S/O Muhammad Roshan and Nadir Ali S/O Muhammad Ali The Applicants/Voters/Residents Of constituencies i.e PS.120 & PS.119 respectively, respectfully bring following objections/memorandum of representation against the delimitation made by the authorities and Would Like to submit the Proposed map of delimitation of our entire district that is Karachi West for your kind consideration.

Objection for the constituencies of PS 119 and PS 120 of District WEST Karachi

1. Total population of PS119 Of district West Karachi is 359069
2. Total population of PS 120 of district West Karachi is 362854
3. Charge # 01 of the subdivision Orangi has been Included in constituency PS 119 Which is unnatural, illogical as well as against the general norms set by competent quarters.
4. Inclusion of charge No.1 of Orangi Sub division has virtually bi furcated union committee 09 Islamia colony of DMC west affecting the availability of civic services the common to the folk by union committee's administration which will affect the either sides.
5. By the Inclusion of charge no 1 of Orangi sub division in PS 119 the compactness of the constituency is also affected.
6. By including of charge #01 of Orangi sub division into PS 119 the homogeneity of the population is also disturbed.

The authorities has unnecessarily crossed/jumped on the main thoroughfare that is main Manghopir Road which is again against the general norms set by authorities themselves.

"Section 20 of the election act 2017, provides that (1) all constituencies for general seats shall, as far as practicable, be delimited have in regards to the distribution of the population in geographically compact areas, physical features, existing boundaries of administrative units, facilities of communication and public convince and other cognate factors ensure homogeneity in the creation of constituency.

(2) for the purpose of delimiting constituency of the general seat of the national assembly of the tribal areas to two or more separate areas may be grouped into one constituency.

(3) as far as possible, variation in population of constituency an assembly are a local government shall not ordinarily exceeded ten percent.

(4) if the limit of ten percent of under sub- section 3 is exceeded in exceptional case, the commission shall record reasons thereof in the delimitation order."

**We propose that**

1. In the light of section 20 of the election act 2017 we suggest the following points before your kind authority that charge 1 of sub division Orangi kindly be included in PS 120 which will help authorities fulfill all the ingredients suggested in the above stated section 20 of election act 2017 that are geographical compactness ,homogeneity, physical features and other facts to greater extent .
2. Charge no 10 and 11 of sub division Orangi be excluded from Ps 120 and be included in to Ps 119 which will fulfill the criteria narrated in the section 20 of the election act 2017.
3. The above stated suggestions are based on the principles of mutual exchange of the charges almost have the same population approximately which will saved the afore said constituencies that is PS 119 and PS 120 form irrational distribution and will make both the constituencies compact without change in their geographical status.

I hope that my request will be given due weightage and be considered on humanitarian grounds and the proposal will be allowed to avoid any injustice in the formation of constituencies by the delimitation authorities.




