**ON DELIMITATION OF P.S 15 DISTRICT**

**KAMBER-SHAHDAKOT SINGH.**

The Applicant/objector submits his application/objections/representation on delimitation of P.S 15 District Kamber-Shahdakot Sindh, as follows:-

1. That Applicant is a citizen of Pakistan being resident District Kamber-Shahdadkot and is an enrolled voter. In proof P.S copy of his CNIC and vote certificate are produced herewith as Annexure A & B.
2. That during current delimitation process of the provincial constituencies of Sindh, the delimitation of P.S 15 Sindh has taken place, which is improper and disturbing, hence the same is challenged.
3. That the map of District Kamber-Shahdadkot showing the actual position of Talukas of District Kamber-Shahdakot clarifying the limits and boundaries is produced herewith as Annexure "C".

4. That the map showing the last position of constituencies of District Kamber-Shahdadkot viz P.S 38, P.S 39, P.S 40 and P.S 42 is produced herewith as Annexure "D".
5. That to make the comparison in between the last map of the constituencies, the map of current position of constituencies along with the list showing the division of population is also produced herewith as Annexure "E"
6. That the fresh proposal of the constituencies of District Kamber-Shahdadkot viz P.S 14, P.S 15, P.S 16, P.S 17, instead of the old constituencies along with the list of proportionate population/role of electorate is produced herewith as Annexure "F"/
7. That the fresh proposal with list of population/electorate is convenient to the citizen of District Kamber-Shahdadkot from every angle, while the current delimitation is totally uneasy and inconvenient to the voter of the concerned constituency.
8. That the fresh proposal of delimitation is based upon average population viz on quota per seat.
9. That the fresh proposal consists the required quota of towns in each constituency of District Kamber-Shahdadkot.
10. That further grounds would be urged at the time of hearing.
11. That no such objections/representation was filled by the Applicant prior to this.
12. That objections/representation is in time.
13. That eight copies of the representation is in time.
14. That it will meet the ends of justice if the present application/representation is allowed.\
